1. UNFORTUNATELY [ ] HAS NOT BEEN ABLE TO PARTICIPATE IN HQS DETAILED DISCUSSIONS. HOWEVER WE MAKING EFFORT TO KEEP HIM UP TO DATE. THE COURSE OF ACTION WHICH WE ARE NOW TAKING, HOWEVER, IS NOT SUBJECT TO MUCH DISCUSSION SINCE IT IS MORE OR LESS DICTATED BY THE GRC.

2. BELIEVE THAT THE REDRAFT OF YOUR LETTER TO THE CCAA IN REF IS EXCELLENT EXCEPT FOR FOLLOWING MINOR MODIFICATIONS:

A. DELETE THE SENTENCE BEGINNING QUOTE ALSO FOR THE LAST NINE MONTHS OF 1967, FOR EXAMPLE UNQUOTE.

B. SUGGEST CHANGING THE PARAGRAPH BEGINNING QUOTE THE OFFER OF CHINA AIRLINES UNQUOTE AND ENDING WITH QUOTE BECAUSE OF SPECIFIC PROHIBITIONS IN THE OTHER CARRIERS' POLICIES UNQUOTE.

APPRECIATE THE OFFER OF CHINA AIRLINES TO DO WHAT IT CAN TO ASSIST IN THE ON-GOING OPERATIONS OF AIR ASIA AND AIR AMERICA AND WE WILL CERTAINLY EXPLORE THE MEANS BY WHICH THIS CAN BE REALIZED. UNFORTUNATELY MUCH OF THE REQUIREMENT FOR TRANSPORTATION CANNOT BE SO MET SINCE IT EXTENDS TO AREAS BEYOND THE FAR EAST. CAT HAS REDUCED FARE ARRANGEMENTS WITH 28 AIRLINES SERVING VIRTUALLY ALL CORNERS OF THE WORLD. RELATIONSHIPS WITH THESE CARRIERS HAVE BEEN DEVELOPED OVER A LONG PERIOD. CAL WILL NO DOUBT DEVELOP SIMILAR RELATIONSHIPS IN THE FUTURE BUT WILL NOT BE IN A POSITION TO EXTEND THEIR BENEFITS TO A NON-ASSOCIATED ENTERPRISE. NEITHER COULD CAL LOGICALLY BE EXPECTED TO GEAR ITS SERVICES TO THE NEEDS OF A PARTICULAR CUSTOMER; ITS INTERESTS UNDERSTANDABLY LIE IN MAXIMIZING THE APPEAL OF THOSE SERVICES TO THE TRAVELLING PUBLIC. THIS IS IN THE BEST INTERESTS OF THE GRC AND ALSO ONE OF THE IMPORTANT CONSIDERATIONS IN THE DECISION TO PHASE CATCL OUT OF THE INTERNATIONAL PASSENGER ROUTES THEN SERVED

AS EXPRESSED IN ADMIRAL STUMP'S AIDE MEMOIRE. IT MAY NOT BE POSSIBLE TO SUBSTITUTE AIR ASIA AND AIR AMERICA WHICH ARE NON-COMMON CARRIERS FOR CATCL AS A PARTY TO THESE AGREEMENTS WITH OTHER AIRLINE COMPANIES AND, THEREFORE, WE WOULD ANTICIPATE LARGE-SCALE CANCELLATIONS OF THEM. IN MANY CASES, THE OTHER CARRIERS' POLICIES WOULD SPECIFICALLY PROHIBIT SUCH ARRANGEMENTS UNQUOTE.

3. DO YOU NOT THINK IT WOULD BE ADVISABLE IN PARAGRAPH B OF THE PROPOSED SOLUTION TO INCLUDE SPECIFICALLY THE NEED TO MOVE GOODS AND PERSONNEL OF ASSOCIATED COMPANIES INTO AND OUT OF TAIWAN QUERY.

4. IN THE FINAL SENTENCE, WE SUGGEST INCLUSION OF THE WORD ECONOMICAL IN ADDITION TO RAPID AND CONVENIENT.
