1. [REDACTED] VISITED ME TODAY TO ASCERTAIN IF HE COULD CARRY ANY DOCUMENTS TO YOU WHICH WOULD BE HELPFUL BY WAY OF PREPARATION. I TOLD ART WE HAD NONE AT THIS TIME.

2. I WOULD LIKE TO EXPLAIN WHAT WE ARE DOING FOR YOUR INFORMATION AT THIS TIME SINCE APPARENTLY [REDACTED] WILL NOT SEE YOU BEFORE YOU LEAVE ON YOUR PLANNED TRIP. WE, ON BASIS OF QUESTIONING BY DEFENSE ATTORNEYS OF DICK WALTERS PLUS OUR OVERALL KNOWLEDGE OF SITUATION, ARE REVIEWING ALL PERTINENT TESTIMONY INCLUDING DICK WALTERS TRANSCRIPTS OF LAST WEEK AGAINST TYPES OF QUESTIONS LIKELY TO BE PUT TO YOU. ADDITIONALLY, LARRY HOUSTON WAS IN YESTERDAY AND WENT OVER A CONSIDERABLE AMOUNT OF AVAILABLE MATERIAL AND WILL BE IN AGAIN TOMORROW. WE HOPE TO MARK UP VARIOUS DOCUMENTS IN SUCH A WAY AS TO PINPOINT USEFUL MATERIAL SO YOU WILL NOT HAVE TO READ VOLUMINOUS TRANSCRIPTS PAGE BY PAGE.

3. WE STILL HAVE NO WORD AS TO WHEN YOU MIGHT BE CALLED BUT SPECIAL PROSECUTOR HAS BEEN INFORMED OF YOUR TRAVEL PLANS AND WILL ATTEMPT TO WORK WITH COURT SO AS NOT TO INTERFERE. WE HAVE ALSO BEEN IN TOUCH WITH ALDRICH WHO IS CONTACT POINT IN STATE FOR SPECIAL PROSECUTOR'S OFFICE AND INFORMED HIM OF YOUR TRAVEL PLANS. HE WILL KEEP US ADVISED OF DEVELOPMENTS. WILL GET FURTHER WORD TO YOU AS SOON AS WE HEAR ANYTHING. BEST REGARDS. E2, IMPDET.
