SUBJECT

Cancellation of AEACRE Administrative Plan

- 1. This memorandum contains a <u>recommendation</u> submitted for SSA-DD/S approval. Such recommendation is contained in paragraph six.
- 2. The SR Division has been considering for many months the question of continuing the AEACRE Administrative Plan. AEACRE was authorized as a project initially on 22 January 1952. On 25 November 1953 an Administrative Plan for AEACRE was approved authorizing operation of this project as a Domestic Operations Training Base.
- 3. The operational scope of AEACRE has since changed substantially. The Domestic Operations Base presently provides support facilities for operation of the following projects:

AEDRIFTER	AESCOUTER	AEHANDY

- 4. Agency regulations, coupled with changes in the AEACRE situation, have resulted in an outmoded and unnecessary Administrative Plan. We have, therefore, checked through each provision of the Administrative Plan and have found that these provisions are adequately provided for in Agency regulations. It has therefore outlived its usefulness and need no longer be retained.
- 5. As a new has been appointed effective 15 February 1957, this could serve as a convenient date for effecting the changeover.
- 6. The SR Division recommends that the Administrative Plan for Domestic Operations Base-(AEACRE) be discontinued effective 15 February
