- 1. The purpose of this memorandum is to extend Project AEACRE for a period of six months in accordance with provisions of Reference C, paragraph 11.
- 2. Upon the recommendation of Chief, SR Division, approved by the Deputy Director (Plans), a Study Group was appointed for the purpose of reviewing, evaluating and recommending the reorganization of SR Division's Domestic Operations Base and the transfer of the Base from SR Division to DODS so as to afford the Base an opportunity to better provide support to various components of the Clandestine Services.
