SUBJECT : Project AEACRE (Extension)

1. The attached Project, originating within the SR Division, is herewith presented for your approval of an extension for the period 1 October 1955 through 31 December 1955 with authority, during this period, to obligate [] from the DD/P-SR Division budget.
