In a conference between ______,
following subjects were discussed and conclusions drawn:

- 1. NTS shall remain as a school in Germany. It is not possible for DB to make arrangements for the only presently acceptable instructor to the group on the grounds of poor physical condition. His entry into the United States would be impossible. By October 15 it will be known what teams and what areas these people will be set up for.
- 2. Latvian All future recruitment will be carried on in the United States. AECOB will return to the United States. It consists of two Latvian trainees. Available for the training ard land CAMBERA 1 and CAMBERA 2.
- 3. Lithuanian Will be carried on as a joint operation with the British, planned for Spring 1953.

- 7. In planning for any AESOP-type operation similar to the AESOP-CASINO Project dispatched last May, the following items come up for consideration:
- a. All singleton type agent personnel slated to be dispatched from Japan will be trained at the DB.
 - b. All singleton type agent personnel slated for dispatch from

Germany will be trained in Germany.

- c. The above two points pertain if a large pool of singleton types are recruited (10 or more).
- d. If this large pool is non-existent, then of necessity the training of singletons would be split between DB and CSOB.
- e. On the other hand, if only a small pool of such type personnel exists and if it is desired to dispatch these individuals from Japan, then some decision must be reached as to where these groups will be trained. There is available in CSOB an individual who was utilized as an Assistant Case Officer within the CASTNO Project, who not only is fluent in Russian, but who has developed a certain amount of experience from exposure to a CASINO-type operation. This individual will be transferred to DB for the AESOP type operation.
- 8. In regard to the consultants, or indigenous-type instructors, the following individuals will be made available to DB:
 - a. CALLIDO and family (wife and two children)
 - b. CARGO and family (wife and mother-in-law)
 - c. CAMPEACHY and family (wife and child).
 - 9. U.S. Training Personnel

The individual who has done all the airborne training at CSCB/K and who will also dispatch the groups now in training, will be made available to DB for utilization in a similar capacity there.

- B. 1. Safehouses are available in the United States.
 - 2. A supply room is established in the beadquarters of DE.
- 3. The training areas are provided as needed in Idaho, New Hampshire, Maine, and locally.
- 4. Parachute packing is accomplished under the supervision of Major McDowell, head of the Airborne Section.
- C. Transfer of property and operational equipment will be done in the proper fashion in the future and the reporting officer will carry along some transfer memoranda with him.
- D. Certain operational items will be procured in Germany, however final packing of operational equipment prior to dispatch should be done at the point of final training stage.

SUBJECT: Agenda for Conferences between CSOB and DB

1. Liaison with Air Force

- a. MATS priorities for "Special Procedure" entry passengers flying to the U.S.
- b. Increased assistance on dispatch and target data. (It is not clear in Washington where our point of contact is for operational purposes.)
- c. What airborne training should continue in Germany. What airborne training of agents should be done in the U.S.

2. Official Papers Required for Travel between Germany and U.S.

- c. Notice of transfer of property and operational equipment should be sent to SR/DB at the time case officer and agents enter the United States with the equipment. It is suspected that some equipment is being transferred from Headquarters to the Field and from the Field to Headquarters without proper accounting for property.
- d. It is understood that certain operational equipment and supplies are to be procured in Germany. In most cases final packing of operational equipment prior to dispatch will be done in the field.
