1. Basic Flan AE-ACRE

- a. The plan was approved on 22 January for the remainder of the fiscal year 1952 only. In its present limited scope, the plan provides essentially for the following material support:
 - (1) Establishment of a sterile DOB Headquarters building.
 - (2) Safehouse keepers (couples) for each safehouse.
 - (3) Five safehouses. (Three are already operational)
 - (4) Eleven sterile cars (2 per safehouse, 1 for headquarters).
- a. By July 1952, the phasing out of our training facilities in Germany, combined with the increased agent recruitment in the US will cause a considerable expansion in the scope of DOB operations. DOB will thus require:
 - (1) Sterile Headquarters building (paragraph II a, below).
 - (2) Ten to twelve operational safehouses (preferably farmhouses in neighboring Maryland and Virginia counties.

 These safehouses should be surrounded by sufficient land, 50-70 acres, to provide a certain degree of isolation. The safehouses will continue to be secured through CIA Administrative Services.)
 - (3) 20-30 vehicles, not necessarily new. (2 per safehouse.)
 - (4) Ten to twelve I&S cleared safehouse keeper couples for cooking and maintenance of all safehouses.

(In order to maintain security a covert payroll covering the differential, payments would be prepared in DOB for submission to Finance Division for audit and payment in cash.)

(3) Cover organization would provide necessary supplies and office equipment similar to the ones used by itself.

- c. Field Status
 Requirement:
- (1) Chief, DOB to have same authority as Chief of Field Station.
- (2) The case officers who will be on temporary detached service with DOB should be entitled to extra compensations not exceeding prevailing per diem rates upon approval of Chief, DOB. * See below
- (3) Procurement C.F.R. 8. 1 c (1) (2) (a) (b) (c) (3) authorizes Chief, Field Station to procure items at a cost not to exceed \$2,000 each, excepting major items of equipment.
