 - a. Personnel, page 3 of Memo.

A letter of reprimand for for security violations at this time for actions committed several months ago could not carry the desired effect due to the lapse of time and because he has recently been promoted to a GS-12.


b. Page 3 para d. and page h para k. of Memo.

Language professional personnel such as psychologists, psychiatrists (exclude medical personnel) is very desirable and should be procured where available. After talking with psychologist, of the Medical Office, who recently returned from a survey of satellite nationality agents in European stations, it becomes apparent the psychology of Mohammedans is quite at variancy from that of the Scandinavians and the psychological dictates to handling these agents must take into account their ethnical backgrounds and philosophies. Therefore the psychological assessments vary with nationalities, all other things being equal. Those language and area qualified professional personnel need not be assigned exclusively to DOB but should be readily available from the Medical Office.

c. Liaison with ROM/OIS, page 3 para f. of Memo.

Liaison of DOB Tradecraft Section with RQM/OIS should be thru SR/6 rather than direct as recommended.

Perhaps SR/EX has a comment on this point.

e. Specific Ceilinge for safehouses, covert associates. house trailers and motor vehicles, page 95 para 2 g. Survey Report.

The recommended ceiling of seven safehouses is adequate to house the currently planned operations as follows:

- 1. SR/2 AEBASIN (in training)

- 5. SR/3 (2 Ukraimians) (not in training)
- SR/4 3 spotted a-----
- SR/2 2 Finns (not in training)

However an eighth safehouse is recommended by undersigned as a stand-by. This is vital to handle "crash" deals which are inevitable in order to take advantage of unforeseen opportunities where rapid and flexible action is necessary.

The procurement of safehouses as recommended by the Survey Report is not rapid enough. Procurement of a safehouse thru established Real Estate Procurement requires from 6 weeks to 3 months. and project amendment probably will require another 2 months.

The cailing of eight is based on the assumption that Office of Training will provide safehouses for REDSKIN training which in the past has been laid-on DOB.

If DOB will be required to provide HEDSKIN safehouses. an additional 3 safehouses (total 10) will be adequate as a ceiling. However REDSKIN types will not be procured until firm commitments are laid-on by the Area Branches.

f. Case Officer Pool, page h para j of Memo and page 57, para 3. of Survey Report.

The recommended T/O of 57 (excluding the SAOP) will provide for a Case Officer Pool. The recommendation that the pool be not established is contradictory to the recommended T/O of 57.
