1. As a follow-up to our conversation on 22 January I am forwarding for your use in connection with your review of the CINCEUR Wartime Intelligence Requirements the attached "Change Number 1-59" dated 22 December 1959 which you will find self-explanatory. I have confirmed through DC/FI Plans Group that the attached paper is keyed directly to the documents I sent to you as attachments to referenced 9 December memo.

2. You will note that as in the case of the attachments sent to you in my earlier memo on this subject there are, among the attached sheets, pages that deal with requirements for Albania, Bulgaria, and Rumania, as well as pages dealing with requirements in or concerned with the USSR. These are the concern of EE Division who, according to word I have received from DC/FI Plans, have also gotten a complete set of enclosures sent to them directly. Therefore, per our discussion on 22 January, the sheets concerning requirements for the three European Satellites are sent along to you in order to avoid breaking up this TS assembly but the problem of "acceptance" or "non-acceptance" is strictly EE's concern.

3. The Report of Capability forms referred to in para 4 of my 9 December memo have not yet been received but I will see that they are passed on to you as soon as they are made available to me.

4. As one last word on the subject, we have not yet been pressed for a reply on these CINCEUR Requirements. This will confirm our understanding received 22 January that we should consider these Intelligence Requirements originated by EUCOM separately from the ALCOM Intelligence Requirements being forwarded to you this date USC. I will see that the responses that go from the Agency to the individual military commands reflect that we are dealing with one set of assets in talking about our capabilities to perform against requirements received from the various military commands. Obviously, a system of priorities will have to be set up for the purpose of determining the relative importance of CINCEUR's Requirements vis-a-vis ALCOM's; Intelligence Collection Requirements vis-a-vis U/W Requirements, etc.
