A ________ of points the time involved and amount of work, I don't think the time element would consist when you multiply this by 50 or 100. If everything were stockpiled here the clothing for agents is stockpiled in Frankfurt and we have now filled up enough agents for that area and we would be admitted into thexaxes another area.
