One Pebruary 17, 19 1, a confidential source, who have writed reliable information is the past, advised that as well about the by Kleanth Andoni, Counselor, Albanian United Not one Delegation, during the late afternoon of Pebruary 16, 1, at pre-arranged place in New York City. This source has repulsed that Kleanth Andoni has been excepted in intelligence activities.

During a conversation, of approximately twenty minutes departion, Andoni instructed source to determine if First hyperical travels to Washington, D. C. often. Andoni made no other result homeoming Nyftija and offered no other information about he source indicated to Andoni that he was acquainted with Fost which is not on a close personal basis and that he had no informat a supply any trips Nyftija may have made outside New York City.

On Physian 17, 1961, source advised it is generally believed in Alberian emigre circles that Pust Myftija works for an American intelligence agency. He said Myftija had not personally mentioned this to him but that he had heard it in conversations with Alberian friends of his in New York City. According source, Myftija has apparently not attempted to conceal the fact that he is working for American intelligence and has tried to reate an impression that he has a man of influence with Africa of the United States government. Source advised he is a ware that a line of his has travelled outside New York City but did not anow the capase of such trips.

Andoni made arrangements to meet source during the firm who would be April, 1961.

## MEMORANDUM

Re: Kleanth ANDONI

It is suggested that the confidential source reply to ANDONI that MYFTIJA makes occas ional trips to the WASHINGTON, D. C. area, but that source does not kn ow whom he sees. It is rumored that he has been doing some translation work for the Department of Defense. Source has gained the impression that MYFTIJA has been trying to build himself up in Albanian emigre circles as a result of this work, and that he is trying to make himself look more imp ortant than he is.

The foregoing was prep ared for passage to the FBI by CI/Ops/WE on 28 March 1961 and coordinated by SR/DOB by telephone 29 March. This was in response to an oral suggestion from FBI liaison that the situation presented an opportunity for possible exploitation of the source-principal relationship. The circumstances were detailed in Bureau New York field office memorandum of 7 March, 1961, circulated as DEF 71014, 17 March.
