In processing the request for the extension of Project ARMARSH, retroactive to 1 March 1959 and through 31 August 1959, some questions arose, principally concerning the status of ARMARSH/15 and financial payments to him. Since it has been mutually agreed that ARMARSH/15 will henceforth be an asset of ☐, it has been decided that payments to him should be charged to Project ARMARSH funds through 30 June at which time spot payments will be made to him by ☐ and charged to OGA funds allocated to ☐. It is anticipated that a field project outline will be prepared to cover his activities subsequent to 31 August.</p> <p>2. It became necessary to revise our request to obligate \$☐ as was stated in paragraph 1 of the reference. We have now asked for authority to obligate \$☐ to cover the financial aspects of the request for extension: \$☐ for the fiscal year 1959 and \$☐ for the fiscal year 1960.</p> <p>3.
