MEMORANDUM FOR: Chief, SR Division

VIA : FI/OPS/Projects Branch

SUBJECT : Retroactive Termination of Project AEMARSH

1. It is requested that Project AEMARSH be terminated retroactive to 31 August 1959.
2. During the last extension period of 1 March 1959 through 31 August 1959, \$4000 was the authorized amount which was expended under Project AEMARSH.
3. Reference is made to the memorandum for Chief, SR, from Chief, SR/2, dated 18 May 1959, attached, which recommended termination following the formal expiration date, 31 August 1959. The present request for termination is, in addition, a request to provide authority for a \$4000 termination bonus to AEMARSH/1, who was the principal agent of Project AEMARSH. Additional funding will not be required as the \$4000, if authorized, will be paid from a cash deposit which was made on AEMARSH/1's former safe apartment in Frankfurt, Germany.
4. Project AEMARSH is being terminated because all of its agent personnel, with the exception of C 3, have been transferred to other projects, terminated, or are on an inactive status as outlined in the attached memorandum.
5. The two agents that were utilized under Project AEMARSH during the last extension period from 1 March 1959 through 31 August 1959 are being disposed of as follows:
  - a. AEMARSH/1 - OA C35511, 24 February 1959 - has been terminated as of 31 August 1959 because he developed an acute case of tuberculosis which requires extensive rest and treatment at a TB sanatorium. Clearance will be kept active in order to consult with him regarding his past Project AEMARSH activities.

b. [ ] - OA C41981, 10 January 1959 - an internal asset who was recruited by AEMARSH/1 prior to repatriation to Latvia via legal channels, will be assigned a new cryptonym and will be carried on as an independent FI activity.
