<p>It is requested that the Project AEQUOR budget for FY 1962 be increased from [ ]</p> <p>2. In the absence of instructions to the contrary, it had been assumed that Project AEQUOR had been renewed for termination on or about 31 December 1961 (See Reference A) with a budget pro-rated for half a year based on the budget indicated in Reference B, dated 1 March 1961, which notified the Field of the renewal of Project AEQUOR for Fiscal Year 1961.</p> <p>3. The project budget for FY 1961 provided [ ] for the newspaper subsidy and \$1,000 for case officer administrative costs and a contingency fund. Apparently through an oversight the project was budgeted for FY 1962 with only [ ] which covers the newspaper subsidy for the last six months of the project but leaves no funds available for administrative expenses and contingencies.</p> <p>4. MOG has already expended \$310 over the [ ] budgeted for FY 1962. Other minor expenses of an administrative nature can be expected in the final stages of the termination. Therefore, an addition of \$500 to the project should cover all project expenses foreseeable at this time.</p> <p>5. It should be noted that Headquarters approval of the [ ] requested by AECAMBISTA-15 (See EGMA-57275) is not considered in the above estimate and would necessitate an additional increase equal in dollars to [ ]</p>
