1. FOLL FROM AECASS 3 OCT 26 WHO OBTAINED INFO FROM AECAVATINA 5:

A. SMOTH ABLE ASCERTAIN THAT "MARKO" WT OPERATOR (SEE PARA 1 D REF A)

NOT SENDER RECENT WT MSGS; HOWEVER NEW WT OPERATOR ATTEMPTING DUPLICATE ALL IDIOSYNCRACIES AND MISTAKES OF "MARKO".

B. *MAT VIEYKO*
MYRON STILL ALLEGED AUTHOR MSGS.

C. RECENT MSG RCVD INDICATES MYRON DISPATCHED BOHUN WEST 9 OCT IN COMPANY TWO-THREE OTHERS. (SMOTH EARLIER TRANSMITTED APPROPRIATE CONTACT INSTRUCTIONS IN BRLN FOR BOHUN USE.) ACCORDING AECAVATINA 5 NO ONE IN EMIGRATION KNOWS BOHUN WITH EXCEPTION SMOTH SKOB.

D. *file*
AECARTHAGE 19 TOLD 5 SHE OPINES THAT 20 LEARNED SHE CONFESSED (BECAUSE OF TEARS, CERTAIN SIGNS MADE BY 20 TO 19 IMMEDIATELY AFTER HER CONFESSION, ETC) AND THAT BOHUN DISPATCH SECOND ATTEMPT DECEIVE EMIGRATION (AND THEIR SPONSORS), ON HEELS LACK SUCCESS AECARTHAGE 20 OP, THAT HOMELAND UNDERGROUND NOT CONTROLLED.

E. AECVATINA 5 REQUESTED ADVICE FROM AECASS 3 SINCE BELIEVES POSSIBLE BOHUN AND ASSOCIATES MAY BE UNCONTROLLED BUT SENT BY MYRON OR OTHER WHO CONTROLLED.

F. BOHUN, AS PLENIPOTENTIARY FROM HOMELAND, AUTHORIZED BY MYRON TO SPEAK WITH REPS ANTI-BANDERA ZCHOUN, AECASSE 1 AND OTHER SEGMENTS UKE EMIGRATION.

2. FOLL FROM ~~HAYOKHA~~ ^{ARM ZENKO} TO AECVATINA 5 TO AECASS 3:

A. BANDERA DID DISPATCH THREE AGENTS TO UKRAINE DURING 55.

B. SKOB AND OTHER SMOTH TRAINEES NOW LIVING LEGALLY GB.

C. BANDERA CONVINCED MYRON NOT ALIVE OR IN HANDS RIS. BANDERA BELIEFS BASED ON INFO RCVD THRU (FEMALE) FNU POKOTILLO, RESIDING VIEN. AECVATINA 5 BELIEVES POKOTILLO IN CONTACT (METHOD UNKNOWN) WITH "YURCHIK" BORODAYEVYCH. POKOTILLO RECENTLY SEEN BY ~~VERNYHORA~~, ~~IVAN~~ IVANOCHKO WHO VISITED VIEN.

D. AECVATINA 5 FEELS ~~"KARMEN"~~ ^{x-ref} LETTER (SEE REF B), INTERCEPTED BY ANTI-BANDERA ZCHOUN, PART OF ABOVE COMPLEX.

3. FEEL RIS INSISTENCE DISPATCH BOHUN WEST, DESPITE SMOTH INABILITY PROVIDE REQUESTED ASSISTANCE, POSSIBLY RELATED RIS STATEMENTS TO AECANDIOT (SEE REF C) RE MYRON.

4. SINCE AECASS 2, IN LETTERS TO AECVATINA 5, MAKES REFERENCE TO INFO OBTAINED BY AECASS 3 FROM AECVATINA 5, AECASS 3 REQUESTS AECASS 2 BE ASKED NOT REFER TO ABOVE MATERIAL IN LETTERS TO 5 TIME BEING UNLESS SAME INFO ALREADY RCVD BY DIR FROM SMOTH.
