- 2. S is a very active and known former member of the OUN. She also is personally known to our people here, Her husband Petro, FEDORIV, pseud. DALNYCH was chief of the Security Service (SB) of the OUN-UPA and as such member of Provid of Zakerzonya Kray. Caught by the Poles he was sentenced to death and hanged (see "Wojskowy Przeglad Polityczny", No 1,1959, "Walki z bandama UPA" by Ignacy Blum.gen.brygady, pp 3-30).
- 3. S was supposed to have been sentenced to 12 years and released in the course of an amnesty. After her release she went probably on a visit to Lviv or some other place in Ukraine and then came back to Poland.

4. Her friends in Phila, Pa want her to stay for some rime with them in New York.
