SUBJECT: Teofila (Fila) FEDORIV nee BZOVA, Poland

DATE: 30 June 1960

- 1. S. went from Poland via Toronto, Canada on about 20 June 1960 to Edmonton, Canada to visit her brother-in-law who is living in Edmonton or in vicinity. She is going to return to Poland.
- 2. S. is very active and known former member of the OUN. She also is personally known to our people here. Her husband Petro FEDORIV, pseud. DAINYCH was chief of the Security Service (SB) of the OUN-UPA and as such member of Provid of Zakerzonya Kray. Caught by the Poles he was sentenced to death and hanged (see "Wojskowy Przeglad Polityczny," No. 1, 1959, "Walki z bandama UPA" by Ignacy Blum. gen. brygady, pp 3-30).
- 3. S. was supposed to have been sentenced to 12 years and released in the course of an ammesty. After her release she went probably on a visit to Lviv or some other place in Ukraine and then came back to Poland.
- 4. Her friends in Philadelphia, Pa. want her to stay for some time with them in New York.
 - 5. It is very important for us to get in touch with her.
