PER REF PARA 5 WE WILL ACCEPT AECASSOWARY 29 AS SINGLETON AGENT UNDER FIELD CONTROL PROVIDED HE HAS COVER AND DOCUMENTS WHICH WILL PERMIT HIM LIVE LEGALLY FEDREP AND PROVIDE PLAUSIBLE SOURCE HIS INCOME AND EXPLANATION HIS OPS TRAVEL. DOUBT MEXICAN PASSPORT WILL SUFFICE UNLESS COVER MOST CAREFULLY TAILORED TO IT.

2. MUST STRESS SINGLETON AGENT ASPECT, SINCE IN [] FOB HAS THREE STAFFERS AND LARGE BUDGET COMMITTED SOVIET EMIGRE ACTIVITY. REALIZE THAT REF DOES NOT SPECIFY FOB OR AECASSOWARY 29 ROLE IN AECASSOWARY GROUP ACTIVITIES, BUT IN VIEW OF PAST EXPERIENCE IN HANDLING AGENTS WHO HAVE RESPONSIBILITY TO EMIGRE MOVEMENT AS WELL AS KUBARK WE ARE RELUCTANT RISK ADDITIONAL COMMITMENT THIS BASE IN EMIGRE FIELD. PER DISCUSSIONS [] AND [], FOB IS TO EXAMINE MARGINAL OPS ACTIVITY WITH VIEW TO CUT BACK IN COMING MONTHS. IF FOB THRU AE-29 IS TO BECOME INVOLVED WITH ANOTHER EMIGRE GROUP, THEN SUGGEST REVAMPING [] COMMITMENTS TO PERMIT US TAKE ON AECASSOWARY WITHOUT ADDITIONAL FUNDS OR PERSONNEL COMMITMENTS.
