1. RAIS TUZMUKHAMEDOV PRESS ATTACHE SOV EMB BANGKOK 54-55. RECALLED SUDDENLY SEPT 55. EN ROUTE SMOTH MADE CLANDESTINE UNSUCCESSFUL DEFECTION ATTEMPT KARACHI AND ROME. SUBJ BELIEVED UZBEK NATIONALIST, UNDER CLOUD DUE ANTI-RUSSIAN ATTITUDES REMARKS. SMOTH GAVE [ ] STORY DEFECTION ATTEMPT.
2. SUBJ HAS WIFE AND CHILD, SPEAKS ENGLISH WELL, STUDIED MOSCOW U, CONSIDERED COSMOPOLITAN INTELLIGENT.
3. SUBJ SCHEDULED ATTEND INTERNATIONAL LAW ASSN BIENNIAL HAMBURG 8-13 AUG. REDWOOD WILL HAVE CONTROLLED OPS ASSET WITH DELEGATE STATUS TO CONTACT AND ASSESS MEMBERS SOV DELEGATION.
