1. REQUEST TRACES, POA PRIOR TO 9 AUGUST TO CONTACT AND ASSESS KIRIL HARBAR, DOB ABOUT 16, UKRAINE, NATURALIZED SWEDE. IN SWEDEN SINCE 45, EMPLOYED AS PARTS INSPECTOR IN FACTORY. ADDRESS: KLOCKAMVAGEN 1, HUDDINGE, STOCKHOLM. NO DEROG [ ] TRACES.

2. HARBAR CLOSE FRIEND SUBJ REF B AND WITTING LETTERS AIS CONTACT SINCE HARBAR WAS INSTRUMENTAL IN ARRANGING (REF A). SUBJ REF B BEEN TURNED OVER TO [ ] 2 AUGUST. SUBJ RECOMMENDED WE RECRUIT HARBAR SINCE HE RELIABLE, HAS GOOD ACCESS UKRAINIANS IN SWEDEN, AND MORE OPPORTUNITIES MEET SOV UKRAINIANS SINCE HE LIVES STOC. BOTH WILL MEET UKRAINIAN DELEGATION FROM PBPRIME DURING AUGUST HISTORICAL CONGRESS STOC. LATTER WILL DEBATE WITH SOV UKRAINIANS WHO EXPECTED ATTEND CONFERENCE.
