It would appear from Reference, and from correspondence on the same subject which has preceded it, that the many words which we have used to launch this aspect of the AERODYNAMIC Project have proved inadequate to convey to you a complete picture of Headquarters intention. Regrettable though this may be, we think it unnecessary to spell out our meaning at greater length here since, by the time of your receipt of this dispatch, you will undoubtedly have discussed the matter exhaustively with the undersigned.</p> <p>2. Suffice it to say here that Headquarters is determined to give this new aspect of the AERODYNAMIC Project a full and fair trial and, consequently, has included AECASSOWARY/29's PCS assignment to Frankfurt as an integral part of this aspect. The conditions you set in paragraph 4 are quite easily met because they were part and parcel of the concept of this effort to derive more positive intelligence from the activities of the AECASSOWARY organization. In other words, FOB will have operational responsibility for AECASSOWARY/29's activity as a REDSKIN principal agent in the Ukrainian field and no operational responsibility for any other aspect of the AERODYNAMIC Project. Similarly, if the activities of AECASSOWARY/15 in PBPRIE and AECASSOWARY/29 in FOB have not produced sufficiently greater and better take by the conclusion of next year's REDSKIN season, it is Headquarters intention to terminate their roles.</p> | | | |
