HORBACH ALSO INVITING SHPORLIUK VISIT GERMANY SOONEST WHEN CONVENIENT. VIEW PARA 2 ABOVE WE DOUBT VISIT COULD TRANSPIRE PRIOR TOO WIDE KNOWLEDGE HIS DECISION REMAIN ENGLAND. THEREFORE BELIEVE POSSIBILITY PARA 3 REF TOO REMOTE ATTEMPT SPECIAL EFFORT BRING SHPORLIUK GERMANY MEET A 29 PRIOR FINAL STEPS HIS REMAINING ENGLAND.
