1. SUBJ REFS SEEMS PROMISING REDSKIN CANDIDATE FOR ASSIGNMENT TO CONTACT AND ASSESS LEADS IN LVOV OBTAINED FROM AECASSOWARY 34 MOTHER. (POUCHING COPIES A-29 REPORTS THIS OP.) ACADEMIC BACKGROUND AND AIMS SEEM HARMONIOUS WITH DESIRE STUDY IN UKRAINE. AS NEXT STEP OUR EVALUATION REQUIRE FOLLOWING: HOW DID A-29 MEET SUBJ, WHY DID HE OFFER SERVICES TO AEBEEHIVE. DOES HE HAVE STRONG NATIONALIST CONVICTIONS. WOULD HE BE WILLING ACCEPT EVEN MINIMAL RISKS. DESIRE FULL A-29 ASSESSMENT INCLUDING INFO ON SUBJ'S DISCRETION, PURPOSEFULNESS, ETC.

2. IF APPROPRIATE REQUEST A-29 SUBSEQUENTLY SUBSTANTIATE HIS FINDINGS BY TESTING SUBJ WITH WECHSLER-BELLEVUE, AS AEBEEHIVE HAS DONE PREVIOUS LEGAL TRAVELER CASES. REALIZE A-29 NOT TRAINED GIVE TEST ALTHOUGH HE HAS TAKEN IT. BELIEVE COULD TRAIN A-29. IF NOT MKTOPAZ HAS PERSONNEL WHO COULD. POUCHING KIT. AS SUBJ NATIVE ENGLISH SPEAKER, ENGLISH LANGUAGE TEST COULD BE USED. RESULTS SHOULD BE SENT HQS FOR INTERPRETATION.
