1. In his letter to Martha and her husband, received Sept 27,1965 KOROTWCH writes among other things the following:

a/ VOVK Vira was hopping around inkiev with PAVLYCHKO in the latter's car and he (Korotych) obviously was unable to compete with PAVLYCHKO in this respect. "Boys" were telling KOROTYCH about Vira's sojourm in Kiev and according to what he was told she left not a bad impression.

b/ "My greetings to Manhattan which I haven't seem, and to a nice boy Kochubei from Ukrainian representation at the UN whom I have met in Kiev".

c/The rest of the letter is about his work, suffering now from slight cold, writing publishing of some of his stuff in Ranok #9.

Also abou his seing Lina (KOSTENKQ) and telling her how much Vira VOVK was delighted and impressed by her.

Also a confirmation that he has received "To Whom The Bell Tolls" and a book on Claude Iserli.

2. Ad Report on Kolaska Ivan, dtd Odt 4, 1965, para 2.; HNATIV M. is the man of Winnipeg, 4, Man. 620 Aberdeen Ave. His daughter Christine HNATIV, student of literarture at Uni of Winnipeg, born 1945 in Vienna, is planning to make a trip to Ukraine in 1966. She is a great admirer of KOROTYCH and other young contemporary poets in Ukraine. In Aug 1965 she visited New York and also paid a short visit to Protog.

From KOLASKA via additional sources: a/HORDYNBKY Sviatoslav was told by Kolaska in Winniper to convey Antonenko-Davydovych's greetings to Hordynsky and Yu.Lavrinenko whose Rozstrilane Vidrodzennia he had the chance to read. (N.B. Rozstrilane Vidrodzennia was smug led in on several occasions by our people.)

at Sosiura's funeral in Kiev and authorities forbade to march along Khreshchatyk. Also half of Malyshko's speech was censored out" but he read it in full nevertheless. Malyshko himself told the funeral mass that he was not reading the speech which he was allowed to, but a completely new one. This speech is being now circulated in handwriting all over Kiev.

c/ During a performance at Kiev Opera in 1965 a singer began to sing "Volga". This cause an uproar among students in the public who demanded to hear "Reve to Stohne Dnipr Shyrokyi".


- 3. Emil Kruba sent a letter (via diplomatic pouch) to Dr M of Paris from Moscow dtd Sept 17,1965. He is planning to visit Kiev and be back in Paris in mid-Jan 1965. Then he wants to see Dr M. Apologizes for not having met him in summer on his way to Moscow via Belgium by car. It looks as though he really might have been unable to keep appointment with Dr M at that time.
- 4. CHUICHUK Vitali, Ukrainian, chemist, aspirant of Kiev University, 26-28, on exchange in France in 1965, married, his wife Russian, one daughter was contacted by our people in Paris in June and Sept 1965. At the dinner with Dr M and Ola R. was given Pengrama by Koshelivets. In summer he stayed at Pavallan International Cite Universitaire, Bd. Jourdan, Paris XIVe and otherwise at the Centre Bullier, Bd. Port-Royal, Paris Ve.

Meetings and conversations brought nothing of real interest, only general information. CHUICHUK stuck mostly to official line, was very rautious and reserved.

- 5. G. Luciani worked as corrspondent for Le Temps (later Le Monde) in 1934 1938.
- 6. To Vira VOVK: Henryk NENRY of Nicea, his true name (as known to Vira V.)-SZUMLEWICZ Henryk.
- 7. According to MORAWSKI Kazimiers of Warsaw, Marszalkowska 4, correspondent of Za I Przeciw, now at the Occumenical Council in Rome, Italy, there are now going on negotiations between Kiev and the Vatican about eventual return of ardinal Slipyi to Ukraine as a Metrop ditan of Kiev. This was told to Dr K. on Oct.1, 1965. Dr K. knew MORAWSKI from last year when they met at the Council. Dr K thinks this was a deliberate provocation on the part of Poles to create a new stir-up among Ukrainian emigration. According to MORAWSKI he could, name the source of his information but "he knwos definitely that the respective draft of agreement between the Ukrainian SSR and the Vatican had 8 pages".
- 8. Rev. BOROVNI Vitali, observer of the Rus ian Orthodox Church at the Occumenical Council left Rome via Geneva on Oct 2,1965 for Moscow and told our Source he hoped to come back around Oct 25, 1965 "with God's will".

 ("As you should know-he told Dr K. from Moscow you can come only with God's will".) They made a tentative appointment for the end of October .1965.
