Contact with UHVR (No. 6)

1. The meeting on 12 August 1946 was arranged to collect some material on members of the Munich Bunker, 1/B-P/5. The reports received were on the following:

2. As to other matters taken up during this meeting, AB-43 made clear to JURKO and JURIK that future relations with them would depend almost entirely on the exactness of the information initially given him (in Reports 272-274 and 279-292). The conversation continued as follows:

AB-43: Of course, there are other points to consider to satisfy my natural curiesity and dispel my distrust of you. For naturally, one cannot be expected to trust an unnamed stranger. ((NOTE: This was the first bid for true names and other personal data on the people involved.)) So far you have had the advantage over me. True, you have given me information and I have given you ostensibly nothing. I have allowed you, however, a position of absolute equality; I have not imposed on you, I have not embarrassed you with prying questions. If this liquidation of Bunker 1/B-P/5 is the end of our relation, then I have no other questions to ask you. If, however, this is only the beginning of our cooperation, I will have to insist on knowing with whom exactly Isam dealing. I have to know not only something on your organization but also somthing on your persens.

JURKO: We are now in process of writing for you a pretty extensive history of the Ukrainian fight for independence, of which we are part. As to us personally, it is true that you know very little. But, as we see it, that is not so tragic for you, because our chief, Dr. HRINIOCH, is very well known to your friend Dr. NOVAK (ARADI, SI/Salzburg).

AB-43: I am sorry, but in this business, I'd rather not depend on any other office (See Report 270). Also, I am not dealing with Dr. HRINIOCH, I am dealing with you. I know little about Dr. HRINIOCH and nothing about you. I do not receive any reports from Dr. HRINIOCH and neither do I evaluate Dr. HRINIOCH's information. I have already indicated my opinion about Dr. HRINIOCH when I established my contact with you. I cannot always depend on Dr. HRINIOCH; reliability and surmise that you too are reliable.

JURIK: But we don't know anything about you either.

AB-43: Oh, yes, you do. You know that I am an American, that I am in American Intelligence Service, that any commitments I may make in the future will be understood by you to commit more than just me personally -- you, on the other hand, commit only yourselves.

JURIK: We too commit more than ourselves.

AB-43: Whom? And how can a nameless person commit a nameless organization?

- JURKO: (To JURIK) You know, our friend here does have something.
 We cannot remain nameless and expect to be trusted. Just
 think, what would you do in his place?
- JURIK: The point is well taken, but I'd rather wait until you come back from Nürnberg on Friday. ((NOTE: They were told that there were several questions I would settle when visited my headquarters.))
- JURKO: (To JURIK) We will wind up by giving him our names and personel history anyway. Let's do it now and have it over with.
- AB-43: Let's make it Friday, then. I want you to make your own free decisions. I did not have you arrested and force you to work with me; neither do I intend to spoil our relations by talking you into something you're reluctant to do. You should, however, not interpret this to mean that I am not only liberal but careless. I am determined either to know you and have you work with me or to terminate our meetings.
- JURIK: In a way I understand your position. You may have what you ask for now.
- AB-43: Since it is already one o'clock and time for lunch, let us leave all this till next Friday. Let's make a tentative appointment for Friday (16 August 1946); will 3:00 p.m. do? OK -- see you Friday.
