- l. AEGARTHAGE 20 Letter. Incoming Message Nr. 8 was discussed with AEGASSOWARY 2. He agreed that the reply from us should be business-like, indicate AEGARTHAGE 19 could not return at this time, and asked for time overnight to think the letter over and to provide his considered comments. Because of other commitments the undersigned could not stay in New York one more day; instead he phoned AEGASSOWARY 2, asking him to deliver his comments to us via AEGASSOWARY 15, whom he plans to see over the weekend—May 25-27, 1956.
- 2. GROTT-SPASOVSKY. W/s has a letter intended for this person, allegedly active in the Ukrainian community in the United States. The letter was written by a German formerly in a Soviet camp in Siberia. The German met GROTT-SPASOVSKY's son in that camp, and the son asked the German to write a letter to his father in the United States. We are unable to locate such a person in this country, and asked AECASSOWARY 2 to attempt to do so. We are still holding the letter pending the possible receipt of information from AECASSOWARY 2. The undersigned was under the impression that the request for data was given to AECASSOWARY 2 several months ago, but AECASSOWARY 2 stated that was not so.
- ABCASSOWARY 2 stated that Fedir YUREVICH, ZP mamber formerly in Munich and who recently emigrated to Denver, Colorada, told him that the Americans have a former OUE/N courier in their possession in Germany. which courier is a native of Kremenets and who went on CUM/N missions from Munich to Kremensts in the years 1945-49. His superior was Yaroslav HAYVAS. who is now in Mew York City. AECASSOWARY 2 stated that the courier disappeared in 1949, but that there was reason to believe that even before that date he was doubled by the RIS. He based his reasoning in HAYVAS! testimony, who sometime in the past told AEGASSCWARY 2 he was suspicious of this courier because he (the courier) while on one mission dallied unexplainably in the Stanislaviv area, when he should have gone direct to Kremenets. On one of his return missions the courier brought documents allegedly showing that fru KUTS, an underground member with MELNIK ties, was murdered by ABCASSOWARY 1 adherents in the underground, probably by AEGASSOWARY 2 himself. This charge: AECASSOWARY 2 stated, was taken seriously by the MELMEKITES and contributed to ZU-CUN/N hostility. We have sent a cable to the Field asking them to I on this matter and also plan to have AECASSOWARY 2 interrogate attempt to get more data from HAYVAS.
- 4. Taroslav HAYVAS. Subject stated that HAYVAS wants to go to Europe in order to investigate the OUN/M courier recently arrived in Munich—ISKRA, who is now involved in the AEPOLKA operation and is being interrogated by UPSWING. HAYVAS is also having trouble getting his citizenship papers—in that no action is being taken by the authorities to give him his citizenship. Why, HAYVAS does not know, although the authorities allegedly told HAYVAS that he was a "mouse in a cat and mouse game," giving no further eludidation. Since

5. Fm SEMINIA. SEMINIA is an American citizen of Ukrainian birth who returned to the United States in February 1956 after several decades of residence in Drohobych, Ukraine, where he was a Baptist missionary. He now lives with relatives somewhere in New Jersey. ARCASSOWARY 2 talked with persons who have talked with SEMINIMA. It appears that SEMINIMA is an old man, but that he may be a useful source of knowledge on post-war Brohobych--its town-plan, population, the Boryslav area oil fields, etc. SEMINIMA allegedly stated that the MVD ordered all Iresidents in his area to write to their relatives abroad. He also stated that tecently the Soviets assigned a large sum of rubles for the building of a Roman Catholic Church in Drohobych. It seems that he should be contacted by 00, Sext State, or even smeone from the SE Division in order to see how knowledgeable he is in matters of interest to the Division.

6. AEGASSOWARY 4's Trip. AEGASSOWARY 4 asked that the undersigned pass on to EMANKIW, SE/7, the word that he, AEGASSOWARY 4, is about to "depart on the trip Blax Blond John wants me to take."

7. Volcdimir KEROD and Rusene PRIEVA. ENCASSERREY 2 asked whether anything had been done toward easing the emigration of these two ment to the United States. Undersigned stated that their emigration does not fall within his province and that his other ATS contacts might more justifiably concern themselves with this matter, since PRIEVA works for the PP side of the AERODYNAPIC Project and MEROD is involved most directly with the Bohdan REMARK PIDHAYEY agent recruitment deal, a matter under the jurisdiction of SE/7. For the undersigned, it is tiring to have to hear the same requests over and over.

8. The HILZ Documents. ARCASSUWARY 2 stated that private Ukrainian groups are now trying to arrange a PP play in an effort to exploit these documents. He stated that they have unearthed some data on ERERHARDT, the German geommandant of Kiev during WW 2; that efforts were being made by the Ukrainian Congress Committee to contact American journalists as well as some representatives in the United Mations. ARCASSOWARY 2 was told that he should discuss the details of such matters with
