Agreement for Joint OSO/OPC Exploitation of ZPUHVR/UHVR

Pursuant to approval by the Assistant Directors of the OSO and OPC Projects, respectively, for the exploitation of ZPUHVR/UHVR and as a result of lengthy discussions among the responsible officers in OSO and OPC, basic agreement has been reached on arrangements for joint development of the projects, as follows:

1. The support and exploitation of the Ukrainian resistance organization ZPUHVR/UHVR within the Ukrainian SSR and elsewhere is a joint OPC/OSO undertaking in which both organizations will share in the benefits.

2. The political support of the organization and its employment for operational purposes other than intelligence procurement will be the basic responsibility of OPC.

a. Representatives of OPC will maintain, initially with the assistance of OSO representatives, all contact with the member of ZPUHVR in the United States who has been charged by ZPUHVR/UHVR with responsibility for developing the support of peoples and governments abroad.

b. Field representatives of OPC will maintain, initially through the OSO case officer, and later jointly with him, such contacts with the members of ZPUHVR in Germany as will be necessary for the conduct of OPC's operations.

c. OPC will provide ZPUHVR with limited financial and material assistance in Germany before contact is established with UHVR in the Ukraine in order to assist in the maintenance of a sound working relationship with ZPUHVR during that period.

3. The employment of ZPUHVR/UHVR for intelligence procurement purposes will be the responsibility of OSO and will be exercised through ZPUHVR, and through UHVR when regular contact with UHVR has been established. In the present phase of operations, OSO will maintain all contact with ZPUHVR in Germany for the purpose of developing direct and regular contact with UHVR at the earliest possible date. When such contact or contacts have been established, they will be jointly controlled and employed by OSO and OPC through their respective field representatives (case officers) working together in Germany.

RECORDS OFFICER STAMP  
OSO and OPC field representatives will keep each other informed on matters of mutual concern and will conduct their joint or separate relations with ZPUHVR/UHVR so as best to serve the security interests of all concerned, to prevent duplications and to reflect agreement between OSO and OPC on all matters that are brought before the representatives of

ZPUHVR/UHVR. Headquarters direction of the field representatives will be carried on jointly by OSO and OPC.

5. A reciprocal basis for exchange of intelligence and operational intelligence obtained from and through ZPUHVR/UHVR will be established in the field. This exchange will take place fully and automatically in the field except with respect to such categories of intelligence as will be the subject of special agreements to be worked out in Washington as the occasion arises.
