Reference B. paragraph 2, requested that an assessment of AERCOOT/5 be made by you based on REDWICK Memorandum Number 37. In Reference A, paragraph 1, it was stated you were starting action on our request. We will appreciate receiving this report at an early date.</p> <p>2. We have processed your renewal request for Project AERCOOT which was forwarded as an attachment to EWFA 28721. As part of the processing of this request, SR/Reports reviewed the positive intelligence production of the project during the current renewal period - 1 February 1959 through 31 January 1960. With the exception of the report disseminated as the result of an interview with the Estonian Bishop, Jan Kivrit, the positive intelligence production was derived from the debriefing of repatriates. It is the opinion of SR/Reports that the only justification for the renewal of Project AERCOOT would be in the rechanneling of the project in the direction of mounted or piggy-back operations.</p> <p>3. It has been noted that in EWFA-28721, attachment, paragraph 6, it is stated that five persons are under active consideration for mounted operations. We wish to call your attention to the fact that, at your request, the FGA for IDENTITY 6 was cancelled. We are unaware of the circumstances which generated your current interest and it is requested that we be advised in order that the Subject's clearance be reactivated. In reference to your active consideration to utilize IDENTITY 9, we wish to call your attention to EWFA-9636 in which it was stated that REDWICK had deferred action on authorization to use him pending the receipt of the information requested in paragraphs 1 and 2. To date, a reply has not been received.
