1. Reference B. paragraph 2, requested that an assessment of ANNOOR/5 be nade by you based on KHANSK Memorandum Bunber 37. In Baference A, paragraph 1, it was stated you were starting action on our request. We will appreciate receiving this report at an early date.

2. We have processed your renewal request for Project ARROOT which was forwarded as an attachment to BOFA 28721. As part of the processing of this request, SR/Reports reviewed the positive intelligence production of the project during the current removal period - 1 Pebruary 1959 through 31 January 1960. With the exception of the report disseminated as the result of an interview with the Estonian Bishop, Jan Milvit, the positive intelligence production was derived from the debriafing of repatriates. It is the opinion of SE/Reports that the only justification for the reneval of Project ANNOT would be in the rechanneling of the project in the direction of sounded or piggy-back operations.

3. It has been noted that in DORA-28721, attachment, paragraph 6, it is stated that five persons are under active consideration for mounted operations. We wish to call your attention to the fact that, at your request, the FUA for INNETITY 6 was cancelled. We are unaware of the circusstances which generated your current interest and it's requested that we be advised in order that the Subject's clearance be reactivated. In reference to your active consideration to utilize INSTRITT 9, we wish to call your attention to MEN-9638 in which it vas stated that HUESE had deferred action on authorization to use him pending the receipt of the information requested in paragraphs 1 and 2. To date, a reply has not been received. We will appreciate receiving this information in order to faciliate the appropriate action required prior to Case Officer contact with the Subject.
