1. PINPOINTING IN IZVESTIYA ARTICLE BY NAME LARGE NUMBER PROMINENT AETNA 1 LEADERS INCLUDING AETNA 7 MAKE IT IMPOSSIBLE AETNA 1 DENY KNOWLEDGE. OBVIOUS AFTER AESMITE PUBLICITY PRESS WILL SEEK OUT AETNA 7 FOR STATEMENT.
2. FOR YOUR GUIDANCE RECOMMEND AETNA 1 DENY US PARTICIPATION, STATE SOVIET ACCUSATIONS ESPIONAGE SABOTAGE UNTRUE AND REPRESENT WEAK EFFORT SOVIET PART RETALIATE FOR AESMITE AFFAIR. REITERATE AETNA 1 HAS LONG CONDUCTED STRUGGLE AGAINST SOVIET POWER ON RUSSIAN SOIL AND WHILE YAKUTA KUDRYAVTSEV CONTINUING THIS TRADITION ALLEGATIONS THEY SPIES SABOTEURS INDICATIVE SOVIET ANXIETY OVER ANY MANIFESTATIONS ANTI SOVIET ACTIVITY IN USSR ITSELF.
3. KUBARK WILL ISSUE QTE NO COMMENT STATEMENT UNQTE HERE IF QUESTIONED BY PRESS.
