1. COMMENTS ON REF WILL BE POUCHED NEAR FUTURE. FOR PRESENT ONLY AEVIRGILITE PROPOSED FOR RETURN GERMANY IS AEVIRGIL-7 WHO HAS RRA VISA AND WILL EMIGRATE CIRCA END MARCH AUSPICES CHURCH WORLD SERVICE.
2. SUBJ HAS TAKEN INCREASINGLY IMPORTANT ROLE IN GROUP DURING PAST YEAR, HAS BEEN KEY FIGURE BROADENING ACTION. CHAIRMAN ORG COMMITTEE FOR BROADENING, WRITER PQLITICAL PLATFORM AND BY-LAWS. SUBJECTS SERVICES MUNI CONSIDERED INDISPENSABLE, PARTICULARLY VIEW HEALTH AND SECURITY PROBLEMS AEVIRGIL-6.

5. WHILE IN U.S. SUBJ WILL HAVE OPS TASKS FOR AEVIRGIL-70. STRONGLY URGE HQ FAVORABLE CONSIDERATION PROPOSAL PARA 8 EGMA 25118. AS MEMBER FRAESIDIUM AEVIRGIL-7 COULD BE EMPOWERED BY AEVIRGIL-1 ORGANIZE BROADENED U.S. CHAPTER INCLUDING ANY USEFUL AND INTERESTED PRESENT MEMBERS PLUS NON POST-WARS.
