1. Forwarded under separate cover as an attachment is a complete list of AEVIRGIL-1 members both in Germany and in other countries as of 26 September 1958. As Headquarters is aware from ECMA-38572, six additional members were accepted at the meeting of the Governing Board on 25 October. Biographical data on these persons will be forwarded as soon as it is available. We will attempt in the future to send information on new members as soon as they are officially received into the organization.

2. You will notice that AEVIRGIL-1 has used the German transliteration of Russian names exclusively. This is the way the names are listed on the AEVIRGIL-1 rolls, and it is consistent with the current spellings used by the people themselves. Another point worthy of mention is that the biographic data for each person is taken from AEVIRGIL-1 records. We have not attempted to change these dates or birthplaces which we know to be incorrect from KUBARK records. Here again, the reason is that the data given is that currently being used by the person concerned; the names, dates and birthplaces in most cases are the ones which the emigrés have used ever since they left the Soviet Union. For all intents and purposes, therefore, they are "official" as far as the West is concerned and most records which are available for tracing will contain them.
