1. 9 APRIL APPOINTED ACTING CO AEVIRGIL PENDING ASSIGNMENT CA OFFICER MENTIONED EGMW 11561. TRANSITION RE AEVIRGIL PRESIDUM SMOOTH AND WELL HANDLED BY WHO REMAINS IN PICTURE AS ADVISOR ON EDITORIAL CONTENT OF PUBLICATIONS. EMPHASIZED NEED STAY WITHIN REDUCED BUDGET, REQUESTED AEVIRGIL PRESENT THEIR OP PLANS FOR NEXT YEAR WITHIN NEW BUDGET. POLITE BUT POINTED DISCUSSION FOLLOWED AMONG AEVIRGIL PRESIDUM MEMBERS IN WHICH IT APPARENT NONE EXCEPT AEV 6 KNEW WHAT BUDGET WAS. CONSIDERABLE PRESSURE WAS PUT ON AEV 6 BY OTHER MEMBERS TO ALLOW THEM PARTICIPATE IN PLANNING ALLOCATION FUNDS.
