1. PER [] DISCUSSIONS 7 MARCH AEV-1 HAS INVITED AEV-202 TO MUNICH 16 MARCH. WILL ATTEMPT HAVE AEV-1 LEADERSHIP ENCOURAGE AEV-202 PUT BLAME FOR DISSOLUTION ON MUNICH CENTER IN ORDER DIVERT ATTACKS FROM SELF. BELGIAN AEVIRGIL CHAPTER MEETINGS BEING HELD 23-24 MARCH.

2. AEV-202 STATED TO [] HE INTENDS RETAIN AEVIRGIL BELGIAN FRAMEWORK WITHOUT MUNICH SUPPORT, WELCOMES CENTRAL DISSOLUTION AS MEANS OF DROPPING DEADWOOD. IF [] ESTABLISHES CONTACT AEV-202, HE SHOULD BE URGED CHANGE NAME HIS GROUP IN ORDER AVOID MUNICH ASSOCIATIONS OR LEGAL INVOLVEMENT.

3. AEV-1 HAS NO FINANCIAL OBLIGATIONS TO AEV-202 AS LATTER DELAYED RETIREMENT ACTION PENDING CLARIFICATION MUNICH PLANS. CAMANTILLA CAN HELP FINANCE HIS HOUSE TO EXTENT OF BFR 100,000. HE SHOULD COVER REST WITH LOAN.

4. NO MUNICH AEVIRGILITES WILL BE SENT TO BELGIUM AND NO INDICATION GIVEN HERE OF OBYOKE INTEREST IN AEV-202. IF CONTACTED BY [] SUGGEST STRONG PITCH FOR KEEPING ALL INTERVIEWS CONFIDENTIAL WHEREBY YOU MAY DEROGATE DISCRETION MUNICH AEVIRGILITES.
