A CAMPAIGN AGAINST GOVERNOR JUAN JOSE TORRES LANDA OF GUANAJUATO WAS BEING CARRIED OUT BY THE NATIONAL SINARCHIST UNION (UNS-UNION NACIONAL SINARQUIA-CATHOLIC, RIGHTIST, ANTI-COMMUNIST POLITICAL GROUP) FOR SOME TIME BEFORE THE ARREST OF ITS LEADERS ON 13 NOV 1964. THE UNS REGARDS GOVERNOR TORRES AS THOROUGHLY UNTRUSTWORTHY BECAUSE HE HAS APPOINTED A NUMBER OF PRO-COMMUNISTS TO POSITIONS OF POWER WITHIN THE STATE AND BECAUSE HE HAS GROSSLY EXCEEDED THE ACCEPTED STANDARDS OF GRAFT IN HIS USE OF PUBLIC FUNDS. THE CAMPAIGN HOWEVER WAS NOT VOILENT AND SHOWED NO SIGNS OF BECOMING SO

AGAINST THE GOVERNOR, COUPLED WITH THE PERSISTENCE OF THE SINARCHIST CAMPAIGN, MIGHT HAVE DEVELOPED INTO A DANGEROUS SITUATION. IN VIEW OF THE RECENT COMMUNIST-LED AGITATION IN PUEBLA WHICH LED TO THE REPLACEMENT OF THE GOVERNOR, IT IS POSSIBLE THAT THE MEXICAN GOVERNMENT ACTED AGAINST THE SINARCHIST LEADERSHIP TO TAKE PRESSURE OFF THE GOVERNOR AND TO AVOID REPETITIONN, ALTHOUGH FROM THE RIGHT THIS TIME, OF ANOTHER PUEBLA INCIDENT).

2. SINCE THE SINARCHIST LEADERS ARE BEING HELD UNDER THE AUTHORITY OF THE ATTORNEY GENERAL'S OFFICE WHICH NORMALLY DEALS ONLY WITH CRIMINAL MATTERS, IT IS POSSIBLE THAT THEY WILL BE CHARGED WITH "SOCIAL DISSOLUTION"! (FIELD COMMENT: THE MEXICO CITY DAILY NOVEDADES OF 24 NOVEMBER REPORTED THAT THE ATTORNEY GENERAL'S OFFICE HAD ANNOUNCED THAT THE UNS LEADERS WOULD APPEAR BEFORE A FEDERAL JUDGE 'HOPEFULLY, BY THE END OF THIS WEEK'. THE ATTORNEY GENERAL SAID THAT HIS OFFICE WOULD

NOT PRESENT THE CASE BECAUSE THE AGITATION TOOK PLACE IN GUANAJUATO STATE. HE ALSO SAID THAT THERE WAS NO DESIRE TO MAKE THE INNOCENT INSTRUMENTS OF THE 23 JAILED LEADERS SUFFER. ATTORNEY GENERAL OSCAR TREVINO RIOS CONCLUDED THAT THE SINARCHIST LEADERS ACTED IN GUANAJUATO PURELY FROM PERSONAL AND POLITICAL MOTIVES ON THE PRETEXT OF POPULAR DISSATISFACTION WITH THE GOVERNMENT OF THE STATE.
