1. Forwarded herewith is Agent Report DAO02314-A-1, S-24009, dated 14 July 1954, subject as above.

2. It is requested that this headquarters be informed if SUBJECT is working for or in contact with another US intelligence agency.

3. This Headquarters realizes that the information contained in the enclosed Agent Report is old, however, it was not forwarded until recently by Region "A". Even though old information, it is believed to be of value since SUBJECT was undoubtedly connected with German intelligence activities in Austria.

On 18 August 1954, a controlled American source reported to this headquarters that ALBERT could furnish information concerning the activities and defection of Dr Otto JOHN. Results of requested ALBERT interview have not been received to date. Information received will be forwarded.

5. REPORT OF FINDINGS			
<p>On 28 June 1964, substantially the following information was submitted to the undersigned Agent by Informant 21-387 through Informant 21-60. Informant 21-167 reported that <u>Theodor von ALB.</u> <u>Boufengasse 3, Salzburg,</u> Land Salzburg, Austria, was engaged in Intelligence activities, but the possibility existed that SUBJECT was in the employ of a Western Intelligence organization. SUBJECT maintained contacts with Czech refugee groups, and had contacts into the GDR. SUBJECT was also an associate of <u>Arcand Fellner</u> born 18 July 1902, Fischbachstrasse 59, Salzburg, editor of Interreport-Ust, a news agency reporting on economic conditions behind the Iron Curtain. Fellner was also believed to be working for the French Intelligence Service. SUBJECT's wife was born in the GDR, but had studied in Yugoslavia. She was presently employed as a chemist at the Boronium Laboratories, Parach. Salzburg. SUBJECT was further in contact with one <u>(Frantisek Kroupa)</u> a US Intelligence Operative, who had recently been convicted by a German court in Bonn, Germany, for mistreating ethnic Germans in Czech labor camps in the GDR, where Kroupa was employed as a camp guard. Informant stated that Kroupa has been removed from German jurisdiction by American authorities and had been taken to France. Another of SUBJECT's contacts was one <u>(Franz Hause)</u> residing in Bonn-Dorf near Bonn, Germany. SUBJECT and Hause had attended schools together in Yugoslavia and Hause is presently a Christian Democratic Union (CDU) representative in the German Bonn Government. Hause frequently meets with SUBJECT at the Cafe Tomaselli, Alter Markt 9, Salzburg, or the Cafe Mozart, Franz Josefstrasse 27 Salzburg; and Hause maintains contacts to the Czech operatives who are engaged in Intelligence activities with SUBJECT.
