1. MGKA 13560, 12 Jan 50:

Heinz ANDERS @ SCHAUTH, Heinz, born 16 August 1916.
Last known address: Braunschweig, Scharnhofstr. 10
Dropped 1 Aug 49 for security reasons.

2. MGKA 12599, 5 Dec 49 — ODEUM Dropped Agent

Heinz ANDERS @ Heinz SCHAUTH, same as above. Reason for discharge:
Underground work, double agent.

3. MGLA 4321, 7 Dec. 50: Guenter ~~HEINZ~~ - probably identical with a former V-Mann Fuehrer, sub-organization 97, who lived in Braunschweig, 10 Scharhorststr. 10, under the name Heinz ANDERS, and in Hannover, Eggerwiese 18, under name Heinz SCHAUTH. In Aug 49 Subject was tried by British for possession of fire arms, two Kennkarten and blackmarketing.

4. MGKA 27454, 8 Mar 51: Guenter HEINZ @ Heinz ANDERS is cousin of Lisa ~~MENSCHER~~. According to ANDERS, Lisa is wife of one Gerhard ~~MENSCHER~~ @ Eugen ~~HEILMANN~~, an RIS agent. ~~MENSCHER~~, who previously lived in Berlin, 68-70 Doenigsweg, allegedly went to SovSector in Feb 50. His wife Lisa, who left him on 1 Feb and went to Braunschweig, is reported to have received letter from ~~MENSCHER~~ dated 20 Feb and postmarked Halle, in which he states he has had Soviet connections for a long time and is now working for them.

One Georg ~~GROSS~~ of Braunschweig reported as traveling to SovZone every four weeks, where he was in contact with Soviets and finally remained (March 50). He reportedly revealed to the Soviets info on the activities of Guenter HEINZ.

5. MGH 11348, 31 July 51: The British provided following info: Heinz ANDERS @ Peter ANDERS @ Peter KIRCHNER had been in indirect contact with a British intelligence agency. He claimed to have held a rank equivalent to Capt. in Waffen SS and to have been captured by the Americans at the end of the war. After an early release he went on the black market ~~and~~ in and around Brunswick. He then, he said, came into contact with American Intelligence and worked for them in Brunswick and then in Hannover (ANDERS conveniently forgot to mention his prison sentence). In July 50 he claimed to work for the Amt fuer Verfassungsschutz & also that he had to report twice weekly to a US office in Berlin-Dahlem. In Aug 50, however, ANDERS admitted that he no longer worked for the Americans but maintained that he was working for the BfV. However, the British think this very unlikely and in any case consider ANDERS worthless and unreliable.
