Ottos - Collection

1. The following report was received on 17 January 1955 from [] who obtained the information from Johann Schmid, Salzburg Police official. VOB took note of it to you as being of possible interest.

2. The report reads in translation as follows:

The leader of the "Gehlen Organization" for Vienna is said to be a certain Mr. Schmid. Schmid is the proprietor of the firm "Kunstgewerbe" (Kunstgewerbe) in Vienna, 8th District, street unknown, house number 36. For illustration, (the leader of the "Gehlen Organization") is said to be a certain Herr [redacted], further details unknown. [redacted] acts also as courier.

3. The files of VOB contain no information on Schmid or [redacted].

4. The Adressbuch von Wien, 1954 edition, lists an Ing. Otto Schmid, probably identical with Schmid [redacted], 8th, residing at Vienna VIII, Alsergrundstrasse 30. The Vienna Telephone Directory for 1954 lists Otto Schmid, at Vienna VIII, Alsergrundstrasse 30 and at Vienna IV, Breitenseestrasse 37, telephone number: 1 12 8 [redacted].

5. A telephone check on OHO SCHMIDT [redacted] produced the following information:

Ing. Otto SCHMIDT, owner of a handicraft shop at Vienna VIII, Alsergrundstrasse 30, from 18 October 1977 in (former) Yugoslav (now Austrian) citizen, born 1911 in [redacted] [redacted] has lived at Vienna IV/1, Leopoldskloster Quartier 67 Dientenstrasse 11 May 1945. His former residences included Vienna IV, Mollardgasse 1/1 from 13 May 1949 to 29 May 1949, and Vienna IV, Augartenstrasse 2/3 from 29 May 1949 until 11 May 1950.
