1. IN APRIL 1979, ARGENTINE ARMY MAJOR H U B E R (FNU) WAS ARRESTED FOR THE UNAUTHORIZED DETENTION OF A SUSPECTED SUBVERSIVE IN CORDOBA. HUBER HAD ORDERED AN ANTI-TERRORIST COMMANDO GROUP TO DETAIN Z A B A L I Z (FNU), WHO WAS SUSPECTED OF PROVIDING FINANCIAL SUPPORT TO THE MONTONEROS. AFTER ZABALIA WAS DETERMINED TO BE INNOCENT AND WAS RELEASED, HE BROUGHT CHARGES AGAINST THE COMMANDO GROUP. HUBER AND TWO OTHER MILITARY PERSONNEL WERE ARRESTED; AS OF EARLY DECEMBER, THEY WERE STILL UNDER ARREST, PENDING A HEARING OF THE CASE BY THE PERMANENT MILITARY COURT FOR COMMANDERS AND OFFICERS OF THE ARGENTINE ARMED FORCES.
