SOURCE PERONS (B) IN CLOSE CONTACTS WITH LEADERS OF THE UNS.

1. THE FOLLOWING MEMBERS OF THE UNION NACIONAL SINARQUISTA (NATIONAL SINARCHIST UNION) WERE ARRESTED IN THE STATE OF GUERRERO ON OR ABOUT 10 OCTOBER 1963: FRANCISCO TORRES, OF TAXCO, GUERRERO; HOMOBONO VAZQUEA, AND TOMAAS NAVA, OF CHILPANCINGO. REYES PAEZ (FNU) UNS LEADER IN CHILPANCINGO HAS BEEN TRYING TO TALK TO THE ATTORNEY GENERAL OF GUERRERO ON BEHALF OF THE IMPRISONED UNS MEMBERS. HOWEVER, THE ATTORNEY GENERAL IS NOW IN ACAPULCO IN CONNECTION WITH THE ARRIVAL THERE OF JOSIP BROZ TITO, PRESIDENT OF YUGOSLAVIA. ACCORDING TO REYES, THE ASSISTANT ATTORNEY GENERAL IN CHILPANCINGO HAS REFUSED TO DISCUSS

THE MATTER WITH REYES, SAYING HE KNOWS NOTHING OF THE CASE. REYES FURTHER SAID THE ARRESTED UNS MEMBERS FROM CHILPANCINGO, HAVE BEEN MISTREATED BY THE POLICE. THE UNS HEADQUARTERS IN MEXICO CITY HAD PREVIOUSLY RECEIVED INFORMATION TO THE EFFECT THAT ALL THE ARRESTED HAD BEEN "SAVAGELY BEATEN."

2. DAVID OROZCO ROMO, NATIONAL DIRECTOR OF THE UNS, HAS INSTRUCTED REYES TO CONTINUE HIS EFFORTS TO FREE THE UNS MEMBERS. OROZCO FURTHER SAID, "WE HAVE NOT DONE ALL WE ARE GOING TO DO IN RELATION TO TITO'S VISIT. WE PROTEST SUCH A VISIT, BUT WE WILL DO NOTHING MORE, AS WE DID NOTHING IN MEXICO CITY OR IN GUADALAJARA." (FIELD COMMENT:

IT IS BELIEVED THAT THE UNS MEMBERS WERE ARRESTED IN ORDER TO ASSURE NO ANTI-TITO DEMONSTRATIONS IN THE STATE OF GUERRERO.)
