1. MAY BE ADVISED THAT ACCORDING TO A DECEMBER 1968 DOCUMENT CONTAINED IN HIS HQS FILE, ANDRIJA ARTUKOVIC, STATELESS, BORN 29 NOVEMBER 1899, IS LIVING IN RETIREMENT ON THE U.S. WEST COAST. THERE IS NO SUBSEQUENT PERTINENT INFORMATION AVAILABLE IN THIS FILE.

2. THE FILE ALSO INDICATES ARTUKOVIC ENTERED THE U.S. UNDER ALIAS IN THE LATE 1940'S. OFFICIAL U.S. EFFORTS TO DEPORT HIM FOR ILLEGAL ENTRY AND PRESENCE WERE INITIATED BUT NOT PURSUED. LEGAL EFFORTS BY YUGOSLAVIA WERE MADE TO EXTRADITE ARTUKOVIC AS A WAR CRIMINAL. U.S. COURTS FOUND THAT THE EXTRADITION CHARGES WERE BASED ON POLITICAL ACCUSATIONS WITH INSUFFICIENT SUPPORTING EVIDENCE OF ACTUAL CRIMINAL ACTIVITY.
