#### Does Artukovic Qualify As War Criminal?

In the Agreement of August 8, 1945 concluded between the U.S.A., Britain, France and the Soviet Union it was said that all those persons who have committed one of the following offenses shall be regarded as war criminals:

a) CRIMES AGAINST PEACE, viz., the planning, preparation, initiation, respectively conduct of a war of aggression, or a war violating international treaties, agreements or guarantees, as well as participation in a joint plan or compiracy for the carrying out of any of the above acts;

b) WAR CRIMES, via., violation of the laws respectively usages of war. Such violations shall include, but shall not be restricted to, the following acts: murder, maltreatment or deportation to slave abor campe, or for any other purpose, of the civilian population of occupied territories, murder or maltreatment of prisoners of war or moribund persons, the killing of hostages, the blunder of public or private property, the deliberate destruction of towns and villages, or devastation which cannot be justified with military needs.

e) CRIMES AGAINST MANKIND, vis., murder, extermination, enalayement, deportation and other inhuman acts against any civilian population before or during war, as well as political, racial or religious persecutions perpetrated in connection with any crime shall represent a violation of the domestic legislation of the country in which crimes were committed, whether or not the person is still in that country or in another country.

The leaders, organizers, instigators respectively accomplices who participated in the planning or implementation of a joint plan respectively conspiracy with the aim of committing any of the above crimes shall be liable for all acts committed by anyone in the carrying out of such a plan.


Yugoslavia is a federation of six republics, of which Croatia is one. There are five peoples who speak three very similar languages.

#### Marder Artukovic's Profession and Obsession

ANDRIJA ARTUKOVIC is a notorious criminal. His criminal tenden-



cies date back to 1929 when, as a young lawyer, he joined the terrorist organization called USTASHI. Made up of chauvinists-religious and fanatical cut-thoate—whose oath of allegiance demands complete submission to the leadership of the USTASHI until death, ANDRIJA ARTUKOVIC soon became an USTASHI leader. USTA-SHI tasks, prior to the onstrught of the axis powers against Yugoslavia, were murder, promotion of hatreds, and weakening internal solidarity of political, military and economical power of Yugoslavia.

#### Artukovic Expert on Escape Tactics

In 1929, together with Pavelić, AN-DRIJA ARTUKOVIC escaped from Yugoslavia because of their illegal activities. In Hungary they joined with their terrorist henclmen and set up an USTASHI training camp in JAN-KA PUSZTA. From there they operated newspapers and carried on other activities in cooperation with their USTASHI who still eperated illegally in Zagreb.

By 1931, USYASHI organized many camps in Italy. Their list of ext-throat criminals was now raciled by KVATERNIK, BUDAK, LUBURIC, MOSKOV, LISAK, etc., all later to become high functionaries in the so-called "Independent State of Croatia" government.

ANDRIJA ARTUKOVIC, exiled from Yugoslavia, crossed filegally again and continued his activities. His presence was discovered when in 1932 he lead the "Lika Revolt." (Croatia) an insurrection which consisted of murder of some peasans in Lika and the bombing of the police station.

Hunted by the police, ANDRIJA ARTUKOVIC escreped to Italy, now the new headquarters for their USTASHI organization. Upon his arrival to Italy, he assumed command of the most notorious USTASHI training camp in Bovigno.

#### Extradited from France for Murder

Artikovic was one of the USTASHI leaders, arrested for plotting and succeeding in assassinating King Alexander and French Foreign Minister Louis Barthou in Marseilles, France, 1934. In 1935 at the request of the Yugoslav gevernment, ANDRIJA ARTUKOVIC was extradited from France. Musosilini and religious circles relasted to currender PAVELIC and KVATERNIK. Pavelic and Kvaternik were sentenced to death in absentia by France and Yugoslavia. The lesser USTASHI were sentenced to serve jail terms in France but were letter released by HITLER.

Meanwhile, awaiting-trial in Yugoslavia, the then Belgrade government aligned itself politically with Hitler and Musalolini, ANDRIJA ARTUKO-VIC was released from prison.

This Ustasha believed himself innocent because he killed only 631

When an eye-witness, Gjordana Friedlender testified against ANTE VRBAN, USTASHA Commander of Stara Gradiska, concentration camp notorious for killing thousands, espedally children, she said:

... At that time women and children came daily to Camp Stara Gradiska, Vrban ordered all children to be separated from their mothers and put in one room. Tenof us were told to carry them there in blankets. The children crawled about the room and one crawien soons the room and one child put an arm and leg threigh the doorway, so that the door could not be closed. Vrban shoot of Push fit When I did not do that, he banged the door and crushed the child's leg. Then he took the child by the whole keg, and banged it against the wall until it was dead. When the room was full, Vrban ordered that polcon gas be used to kill the rest."

And what did ARTUROVIC'S AN-TE VRBAN say in his defense when on trial for murdes? He shouted:

But I did not kill bundreds of children personally-I only killed Dr. Nikola Nikolic in Jasenovac

In his book, Dr. Nikola Nikolić, one of the lucky survivors from Jasenovae concentration camp-exchanged for some German prisoners-relates some unbelievable human atrocities committed in Jasenovac.

One of the most notorious was Miroslav (Majstorović) Filipović who headed a group called executioners.

Filipović came to Jasenovac following the unparallelled savage slaughter in the village of Krivaja near Banja Luka.

Filipović was a Franciscan monk. Dressed in his robe he entered the classroom of the little village schoolroom wearing an USTASHI cap. He ordered the teacher, Mara Sunjić, to separate the Serbian Orthodox children from the Catholics. When she did that, not suspecting any evil, he slaughtered these Serbian children before the eyes of their little playmates.

The children ran around the classroom with their throats dashed, blood spattering all around, their little faces contorted in pain and terror. Most of the remaining children went insane, while Mara Sunjić, once a strong healthy girl, today lives and relives in horror that day. Only ruins remain of Mara Sunjic.

So ravage was this slaughter that Filipović fled to Zagreb. So pleased were his leaders with his hatred for the Serbs that Artuković immediately gave him the rank of Major in the army and assigned him to Jasenovac Concentration camp. Filipović exchanged his Friar's robe for an USTASHI uniform and in Jasenovac become a crazed killer.







When Croatia was liberated in 1945, the people tore down flags, in-signias and all remnants of the US-TASHI and NAZI reign of terror. Upon discovering the bodies of thousands of victims thrown in mass graves, ditches, ravines, bodies stuffed in rells, some headless, skeletons left in the fields, heaps of bodies washed sahore of the Sava and other rivers, the people became incensed with rage at the elaborate monuments erected with USTASHI and NAZI insignias lying peacefully in beautifully kept ceme-

teries. Many were torn down. Immediately a voice was heard. The Archbishop of Zagteb (Cardinal) Stepinac wrote in a pastoral letter dworf september 21, 1945, as well as in a letter addressed to President Tito, protesting the stripping of USTASHI and NAZI groun. He said:

..."In death all mon cases to be encmies. The unsertites less of human decency, springing from Christian love, gives to all men the right of decent bariel."













BURIAL FOR ARTUKOVIC'S "BEASTS" Zagreb, 1941—1945











According to a Los Angeles, California newspaper (1958), Pather Lackovic (escaped priest who collaborated with the USTASHI in Zagreb, Creatia, Yagoslavia, and one of the staunch supporters of Andrija Artukovic) acid. "ME (ANDRIJA ARTUKOVIC) CONSULTED WITH THE CARDINAL (STEPINAC, who was then Archbishop of Esgreb), ON THE MORAL ASPECTS OF EVERY ACTION HE TOCK." Below is a typical exchange of notes showing that ANDRIJA ARTUKOVIC DID HAVE SOME AUTHORITY OVER THE INNOCENT PEOPLE IN CROATIA. The note from the Archbishop of Zagreb deals with the visit from Bogdan Raskovic. Secretary to the Ministry of Communications and delegate of the MAZI (GERHAN) and FASCIST (ITALIAN) Red Cross who made a special trip to Zagreb to intervene on behalf of the many Serbians who were made prisoners in various concentration camps. The Archbishop of Zagreb said:

"This Serbian from Bilgrade was at my home accompanied by a German (NAZI) soldier so that no harm about befull him. "He said: 'Excellency, let all be converted so that they may nave their (Setbian) lives,' I PROMISED TO INTERVENE AND WENT INMEDIATELY TO SEE THE MINISTER OF INTERIOR, ANDRIJA ABTUROYIC. What result came of it I don't know, but I did what I could."




