HORTENSIA B U S S I, WIDOW OF FORMER CHILEAN PRESIDENT SALVADOR A L L E N D E GOSSENS, RECENTLY RECEIVED A TELEGRAM FROM CLODOMIRO A L M E Y D A, A CHILEAN SOCIALIST PARTY LEADER IN EXILE, WHICH ASKED FOR HER HELP IN OBTAINING GUARANTEES FROM GENERAL OMAR T O R R I J O S HERRERA, CHIEF OF GOVERNMENT OF PANAMA, THAT THE PANAMANIAN GOVERNMENT (GOP) WOULD VOTE IN FAVOR OF EXTENDING THE MANDATE OF THE UNITED NATIONS AD HOC COMMISSION ON HUMAN RIGHTS. ALMEYDA POINTED OUT THAT IT WAS IMPERATIVE THAT THE COMMISSION, WHICH WILL MEET IN GENEVA DURING FEBRUARY 1977, BE ALLOHED TO CONTINUE ITS INVESTIGATION OF HUMAN RIGHTS VIOLATIONS IN CHILE.
- 2. ACCORDING TO BUSSI, THE MATTER HAS BEEN TAKEN CARE OF
 BY GABRIEL G A R C I A MARQUEZ, THE INTERNATIONALLY KNOWN LEFTIST
 COLOMBIAN AUTHOR WHO LIVES IN MEXICO, WHO HAS RECEIVED ASSURANCES
 FROM TORRIJOS THAT THE GOP WILL VOTE IN FAVOR OF CONTINUING THE
 COMMISSION. GARCIA MARQUEZ FIRST DISCUSSED THE ISSUE WITH
 PANAMANIAN EMBASSY OFFICIALS IN MEXICO AND, BECAUSE OF THE
 SENSITIVITY OF THE MATTER, IT WAS DECIDED THAT A LETTER FOM
 GARCIA MARQUEZ TO TORRIJOS SOLICITING THE LATTER IS SUPPORT WOULD
 BE HAND-CARRIED TO TURRIJOS IN PANAMA BY A MEMBER OF THE EMBASSY
