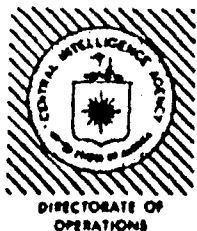

HORTENSIA B U S S I, WIDOW OF FORMER CHILEAN PRESIDENT SALVADOR A L L E N D E G O S S E N S, RECENTLY RECEIVED A TELEGRAM FROM CLODOMIRO A L M E Y D A, A CHILEAN SOCIALIST PARTY LEADER IN EXILE, WHICH ASKED FOR HER HELP IN OBTAINING GUARANTEES FROM GENERAL O M A R T O R R I J O S H E R R E R A, CHIEF OF GOVERNMENT OF PANAMA, THAT THE PANAMANIAN GOVERNMENT (G O P) WOULD VOTE IN FAVOR OF EXTENDING THE MANDATE OF THE UNITED NATIONS A D H O C COMMISSION ON HUMAN RIGHTS. A L M E Y D A POINTED OUT THAT IT WAS IMPERATIVE THAT THE COMMISSION, WHICH WILL MEET IN GENEVA DURING FEBRUARY 1977, BE ALLOWED TO CONTINUE ITS INVESTIGATION OF HUMAN RIGHTS VIOLATIONS IN CHILE.

2. ACCORDING TO B U S S I, THE MATTER HAS BEEN TAKEN CARE OF BY G A B R I E L G A R C I A M A R Q U E Z, THE INTERNATIONALLY KNOWN LEFTIST COLOMBIAN AUTHOR WHO LIVES IN MEXICO, WHO HAS RECEIVED ASSURANCES FROM T O R R I J O S THAT THE G O P WILL VOTE IN FAVOR OF CONTINUING THE COMMISSION. G A R C I A M A R Q U E Z FIRST DISCUSSED THE ISSUE WITH PANAMANIAN E M B A S S Y OFFICIALS IN MEXICO AND, BECAUSE OF THE SENSITIVITY OF THE MATTER, IT WAS DECIDED THAT A LETTER F O M G A R C I A M A R Q U E Z TO T O R R I J O S SOLICITING THE LATTER'S SUPPORT WOULD BE HAND-CARRIED TO T U R R I J O S IN PANAMA BY A MEMBER OF THE E M B A S S Y
