1. MICHEL GORDEY CALLED DCM OFFICE 12 MAY 70 ASK IF DCM HAD ANY COMMENT ON REF CASE. LATTER SAID ~~INTEL~~ HAD NO RECORD, CHECK WITH WASHINGTON REVEALED CASE WNET BACK TO POSTWAR PERIOD AND THAT KLAUS BARBIE WAS SOMEHOW CONNECTED WITH ORGANIZATION AUTHORITIES. DCM SAID KNEW OF NO PRESENT CONNECTION WITH ANY ~~WORLD~~ INTEL SERVICE.

2. GORDEY SAID HE HAD CHECKED FRENCH FOREIGN OFFICE RECORDS AFTER GETTING HIS TIP THAT BARBIE HAD PARTICIPATED IN JEAN MOULIN CASE. RECORDS SHOWED THAT FRENCH AUTHORITIES WERE ALLOWED INTERVIEW BARBIE IN 1950 ON CONDITION THAT THEY NOT ASK FOR EXTRADITION NOR ATTEMPT DISCOVER PRESENT ADDRESS. FRENCH DID ASK FOR EXTRADITION BECAUSE OF POLITICAL PRESSURES, BUT BARBIE WAS PROTECTED BY GEHLEN ORGANIZATION (SIC). FINALLY HEAT BECAME TOO GREAT IN 1951 AND BARBIE WAS ASSISTED IN MOVE TO LATIN AMERICA.

3. GORDEY SAID HIS STORY WOULD SIMPLY STATE THESE FACTS
