BOLIVIA: JACKSON DIEHL FRONT PAGE FROM LA PAZ (FOR STRUGGLING BOLIVIA, BARBIE WAS A CONVENIENT GIFT TO FRANCE, CONTINUED FRONT PAGE SECOND SECTION UNDER HEAD EX-SS CHIEF BARBIE CHOSE WRONG TIME TO PAY A DEBT TO

UNCLASSIFIED

BOLIVIA) WRITES THAT EXPULSION OF KLAUS BARBIE TO FRANCE IS STIRRING UP CONTROVERSY IN BOLIVIA. BARBIE WAS ARRESTED IN JANUARY IN BOLIVIA WHEN HE WENT TO PAY A SIX-YEAR-OLD \$10,000 DEBT TO THE GOB, WHEN BOLIVIAN OFFICIALS DISPUTED THE MANNER IN WHICH IT SHOULD BE PAID. "WITH THAT PETTY ARGUMENT AND AD HOC DETENTION, EVENTS WERE TOUCHED OFF THAT LED TO BARBIE'S CELEBRATED IMPRISONMENT IN FRANCE ON CHARGES OF CRIMES AGAINST HUMANITY -- AND AN ONGOING CONTROVERSY IN BOLIVIA ABOUT THE METHODS AND MOTIVES OF A WEAK GOVERNMENT'S SUDDEN ACTION," DIEHL SAYS. "BARBIE'S SUMMARY EXPULSION BY THE STRUGGLING, LEFT-OF-CENTER GOVERNMENT OF HERNAN SILES SUAZO HAS WON BOLIVA WIDE PRAISE FROM EUROPEAN GOVERNMENTS AT A TIME WHEN THE COUNTRY DESPERATELY NEEDS AID. GRATIFIED FRENCH OFFICIALS SAYS THAT IN ADDITION TO AN AID PACKAGE PLANNED BEFORE THE EXPULSION, THEY INTEND TO 'LEAD A CAMPAIGN FOR BOLIVIA IN EUROPE,' IN THE WORDS OF ONE." IN BOLIVIA, HOWEVER, NOTES DIEHL, THE EXPULSION IS NOT SUCH A SIMPLE ISSUE. "EVEN AS THE GOVERNMENT HAS CONTINUED TO BROADCAST REPORTS ON STATE TELEVISION ABOUT BARBIE'S CRIMES AND EUROPEAN GRATITUDE, LEADING DEMOCRATIC POLITICIANS AND NEWSPAPERS HAVE QUESTIONED THE GOVERNMENT'S HASTY ABANDONMENT OF AN EXTRADITION CASE IN THE SUPREME COURT. THE UNCERTAIN LEGALITY OF THE GOVERNMENT'S LATER ACTIONS...HAVE LED MANY BOLIVIANS TO CONCLUDE THAT THE GOVERNMENT ACTED PRECIPATELY IN THE HOPE OF QUICK POLITICAL GAINS." NEWSPAPER PRESENCIA EDITORIALIZED, "BOLIVIA PRESENTS ITSELF IN THE NOT VERY COMPLIMENTARY ROLE OF SOMEBODY WHO TURNED SOMEBODY IN FOR A REWARD."

GOB OFFICIALS SAY THEY ALWAYS INTENDED TO EXPEL BARBIE. AND JUST HAD THE RIGHT MOMENT BECAUSE HE WAS IN THEIR HANDS. POLITICAL LEADERS ADD, HOWEVER, THAT BARBIE'S ARREST COINCIDED WITH THE GOB'S WORST CRISIS IN ITS FOUR MONTHS. THOSE DIFFICULTUES AND FRANCE'S STRONG INFLUENCE, THEY SAY, ACCORDING TO DIEHL, "CAUSED THE REVERSAL IN THE POLICY OF WAITING FOR A COURT DECISION (IN A PENDING EXTRADITION REQUEST FROM WEST GERMANY) AND AN EQUALLY WORLDLY WISE DECISION TO SEND HIM TO FRANCE RATHER THAN WEST GERMANY." THE SILES GOVERNMENT HAD MANY REASONS TO EXPEL BARBIE, DIEHL NOTES, SINCE HE HAD BEEN ACCUSED OF HAVING CONNECTIONS TO MILITARY GOVERNMENTS AND PARAMILITARY GROUPS AND WELL AS COCAINE SMUGGLING. REPORTS ALSO SAY HE HAD ADVISED MILITARY LEADERS ON TORTURE AND BROKERED ARMS DEALS, ALTHOUGH THERE NO PROOF HAS SURFACED OF THESE CHARGES. GOB CRISIS IN JANUARY ORITY PARTY,

PARTLY BECAUSE IT CLAIMED SILES WAS NOT ACTING AGAINST RIGHT-WING PARAMILITARY GROUPS AND COCAINE TRAFFICKERS. THE CRISIS FORCED THE CANCELLATION OF A TRIP TO FRANCE BY SILES, WHERE AN AID PACKAGE WAS SCHEDULED TO BE ANNOUNCED. THREE DAYS AFTER SILES' SCHEDULED DEPARTURE, BARBIE SHOWED UP TO PAY HIS DEBT, APPARENTLY EAGER TO SETTLE ANY DISPUTES THAT COULD HAVE GIVEN THE GOB AN EXCUSE TO ARREST HIM. ELEVEN DAYS LATER HE WAS ON HIS WAY TO EUROPE. VICE PRESIDENT JAIME PAZ SAYS THE ARREST WAS A POLITICAL DECISION, MADE FOR EXTERNAL AND INTERNAL

REASONS. PROCESS OF ARRANGING A DEPARTURE DRAGGED AT FIRST "BECAUSE OF SECOND THOUGHTS BY BOLIVIAN OFFICIALS OVER THE QUESTIONABLE LEGAL MEASURES." PRESSURE FROM FRANCE HELPED DECIDE THE QUICK EXPULSION, PARTLY BECAUSE OF THE PENDING AID PACKAGE AND PARTLY BECAUSE FRANCE COULD HELP BY ALLOWING THE PLANE TO REFUEL IN ITS TERRITORY OF FRENCH GUYANA, AVOIDING STOPOVERS IN THIRD COUNTRIES. NOW, SAYS DIEHL, "FRENCH OFFICIALS SAY THE AID PACKAGE WILL BE ANNOUNCED WITH FANFARE DURING A RESCHEDULED TRIP (BY SILES) IN THE COMING WEEKS. MEANWHILE, FRANCE WILL BACK BOLIVIA'S EFFORTS FOR FINANCIAL AID IN INTERNATIONAL ORGANIZATIONS AND URGE OTHER EUROPEAN COUNTRIES TO HELP THE GOVERNMENT." WHILE GOB OFFICIALS SAY THE POLITICAL AND ECONOMIC AID IS WELCOME, THE INTERNAL POLITICAL EFFECT OF THE EXPULSION MAY NOT BE AS BENEFICIAL, SAYS DIEHL, SINCE BOLIVIANS HAVE MANY MORE PROBLEMS THAN KLAUS BARBIE TO WORRY ABOUT. EL SALVADOR: NEWS BRIEF "FOR THE RECORD" IN "AROUND THE WORLD" COLUMN PAGE 13 SAYS THAT ACCORDING TO THE GOES, GUERRILLAS CONTROL THE STRATEGIC TOWN OF TEJUTLA, 35 MILES NORTH OF SAN SALVADOR. THE TOWN IS AN IMPORTANT GATEWAY TO GUERRILLA STRONGHOLDS IN CHALATENANGO PROVINCE, SAYS ITEM.

EL SALVADOR: AP FROM SAN SALVADOR PAGE 7 (MAGANA VOWS LEGAL THAW, BARS REBEL TALKS) WRITES THAT PRESIDENT MAGANA SAYS HE WILL NOT NEGOTIATE WITH LEFTIST GUERRILLAS, BUT PROMISES TO APPOINT A "PEACE COMMISSION," WHICH HE SAID WILL RELAX REPRESSIVE LAWS. REBELS, STEPPING UP THEIR MILITARY CAMPAIGN, GAINED CONTROL OF TOWN OF TEJUTLA FOR THE SECOND TIME THIS YEAR, SAYS AP. WESTERN MILITARY OBVERSER SAYS, "THE GUERRILLAS ARE ORCHESTRATING THEIR OFFENSIVES MORE OFTEN THAN BEFORE." BUT, SAYS AP, "IT IS UNCERTAIN WHICH SIDE IS AHEAD IN THE 40-MONTH-LONG CIVIL WAR THAT HAS CLAIMED AN ESTIMATED 42,000 LIVES." AP'S SOURCES SAY THE US IS PUTTING MORE PRESSURE ON THE GOES MILITARY TO CHANGE ITS TACTIS OR RISK LOSING THE WAR. EL SALVADOR/CUBA/GUYANA: VIRGINIA PREWETT OP-ED COLUMN PAG-E 2C (EL SALVADOR AND THE CULT-LEADERS OF THE LIBERAL LEFT) SAYS THE SOVIETS AND FIDEL CASTRO GET AWAY WITH THEIR BUILDUP OF POWER IN THE CARIBBEAN BASIN BECAUSE THE US LEFT ABETS THEM. NOW, SHE SAYS, "CULT-LEADERS OF THE US LIBERAL LEFT ARE GOING FOR A NEW VICTORY -- IN EL SALVADOR." ARGENTINA: RETUERS-BUENOS AIRES REPORTS ("ARGENTINE AMNESTY HINTED FOR SOLDIERS, REBELS" P. 2) THAT ARGENTINA'S MILITARY GOVERNMENT PLANS TO EXPLAIN OFFICIALLY HOW IT CRACKED DOWN ON LEFTIST GUERRILLAS IN THE LATE 1970S AND WILL PARDON BOTH SOLDIERS WHO COMMITTED HUMAN-RIGHTS ABUSES AND THE GUERRILLAS, MILITARY SOURCES REPORTED YESTERDAY. THE MEASURES WOULD BE ANNOUNCED SIMULTANEOUSLY SOME TIME NEXT MONTH, THEY ADDED. "THE JUNTA'S INITIATIVE IS AIMED AT SOLVING ONE OF THE MOST EXPLOSIVE PROBLEMS IN ARGENTINA'S PLANNED RETURN TO DEMOCRACY BY MARCH, 1984. AT ISSUE IS THE FATE OF UP TO 30,000 PEOPLE WHO DISAPPEARED DURING THE ANTI-GUERRILLA CAMPAIGN." HUMAN RIGHTS GROUP ALREADY HAVE OPPOSED PARDONS, SAYING THE ARMED FORCES LACK THE MORAL AUTHORITY TO ABSOLVE THEMSELVES OF RESPONSIBILITY FOR ACTS THEY COMMITTED. THE MILITARY SOURCES SAID THE PROPOSED ARMED FORCES DOCUMENT WOULD BE MORE OF AN EXPLANATION OF HOW AND WHY THE ANTI-GUERRILLA CAMPAIGN HAD BEEN CARRIED OUT. "IT WOULD NOT BE A DETAILED EXPLANATION OF WHAT HAPPENED TO THE PEOPLE OFFICIALLY LISTED AS MISSING BY THE HUMAN RIGHTS GROUPS." EL SALVADOR: REUTERS-WASHINGTON ("MORE US TROOPS IN SALVADOR SOUGHT" P. 4) HAS SMALL NOTE THAT DEFENSE SECRETARY CASPAR W. THIS WOULD REPRESENT AN INCREASE OF AT LEAST 20 PERCENT. SALVADORAN REBELS SAID TODAY THEY HAD REGAINED CONTROL OF NORTHERN MORAZAN PROVINCE, BUT THIS WAS NOT CONFIRMED.

(ED RABLE) CBS NEWS PURCHASED FILMS OF SALVADORAN GUERRILLAS IN TRAINING FROM SALVADORAN FILMMAKERS WHO ARE SYMPATHETIC TO THE REBELS. THE FILM IS DESIGNED TO SHOW THEM AT THEIR BEST, AND THAT SEEMS PRETTY GOOD. WE SEE WHAT TOOK PLACE LAST JULY AND AUGUST IN MORAZAN PROVINCE. DURING THIS CAMPAIGN THE REBELS SAID THEY WERE ABLE TO CAPTURE TRUCKLOADS OF ARMS, AMMUNITION AND SUPPLIES -- A LOT OF IT FROM THE U.S. LEFT BEHIND BY GOVERNMENT DEFENDERS. WHAT IS REVEALED ON THE FILM IS A KEY REBEL BATTLE TECHNIQUE. THE OBJECTIVE IS TO FIRST OVERTAKE A LIGHTLY DEFENDED TOWN, KNOWING NEXT GOVERNMENT REINFORCEMENTS WILL BE SENT INTO THE TERRAIN, WHICH IS

WELL KNOWN TO THE GUERRILLAS, PERFECT FOR AMBUSHES. ON AUGUST 22ND, WE ARE TOLD, GOVERNMENT TROOPS FELL INTO THE REBEL TRAP. THE GOVERNMENT SUFFERED 563 CASUALTIES, ACCORDING TO THE GUERRILLAS. NEITHER SIDE IS WINNING THE WAR MILITARY, BUT IN THE WAR OF PROPAGANDA THE GUERRILLAS SEEM TO HAVE AN EDGE. WHILE THE GOVERNMENT IS ACCUSED INTERNATIONALLY OF KILLING AND TORTURING INNOCENT CIVILIANS, THE REBELS ARE TURNING OVER PRISONERS OF WAR TO THE INTERNATIONAL RED CROSS, MAKING SURE PICTURES ARE TAKEN FOR THE WORLD TO SEE. THEY ARE NOT WITHOUT A SENSE OF PUBLIC RELATIONS AND UNDERSTANDING OF THE MODERN NEEDS OF REBELLION.

FEIGHAN (D-OHIO) THAT, DURING A BACKGROUND BRIEFING WITH THE US MILGROUP COMMANDER IN SAN SALVADOR LAST MONTH WAS INFORMED THAT "THERE CAN BE NO MILITARY VICTORY OVER THE REBELS?"
- A: I AM IN NO POSIBITION TO COMMENT ON WHAT I SUPPOSE AS A BACKGROUND BRIEFING ON THE MILITARY SITUATION IN THAT COUNTRY. I WOULD LIKE, HOWEVER, TO ADDRESS THE POLICY CONSIDERATIONS IN THE QUESTION. AS HAS BEEN INDICATED BY A NUMBER OF ADMINISTRATION OFFICIALS IN TESTIMONY BEFORE CONGRESS, AS WELL AS FROM THIS PODIUM, WE ARE TRYING TO DO TWO THINGS IN EL SALVADOR: WE'RE TRYING TO GIVT IT ENOUGH MILITARY ASSISTANCE TO HOLD OFF THE INSURGENTS; ILITARILY, BUT TO PREVENT THEM FROM PREVAILING, WHILE REFORMS BRING ABOUT CHANGES IN THE POLITICAL HABITS OF THAT COUNTRY, SO THAT IN THE END THE INSURGENTS
- ARE IRRELEVANT AS FIGHTERS, AND THERE OCCURS THE KIND OF POLITICAL SOLUTION THAT HAS EMERGED IN A NUMBER OF OTHER COUNTIRES THAT HAVE HAD THIS SORT OF INSURGENCY IN LATIN AMERICA. VENEZUELA IS A CASE IN POINT.

- -- REMAINS OF JOHN SULLIVAN IDENTIFIED --
- Q: CAN YOU CONFIRM THAT THE REMAINS BURIED IN NUEVO CUSCATLAN, AND EXHUMED THURSDAY, FEBRUARY 18 ARE THOSE OF JOHN SULLIVAN?
- A: THE DEPARTMENT HAS BEEN INFORMED BY THE OFFICES OF CONGRESSWOMAN ROUKEMA AND CONGRESSMAN TORRICELLI THAT A COMPLETE EXAMINATION OF THE REMAINS WHICH TOOK PLACE THIS WEEK IN NEW YORK HAS CONFIRMED THAT THE REMAINS SHIPPED FROM EL SALVADOR FEBRUARY 19TH ARE THOSE OF JOHN SULLIVAN.
- Q: WILL THE DEPARTMENT CONTACT THE SULLIVAN FAMILY?
- A: I AM CERTAIN THE DEPARTMENT WILL CONTACT THE SULLIVAN FAMILY TO OFFER OUR SINCERE CONDOLENCES.
- Q: HOW WERE THE REMAINS DISCOVERED?
- A: ON JUNE 10 THE U.S. EMBASSY IN EL SALVADOR RECEIVED AN ANONYMOUS LETTER WHICH SAID THAT THE BODY OF A MAN WHO APPEARED TO BE AN AMERICAN WAS BURIED IN A SMALL TOWN (PLAN DE LOPEZ, NUEVO CUSCATALAN) OUTSIDE THE CITY OF SAN SALVADOR. ON THE BASIS OF THIS INFORMATION, THE EMBASSY INVESTIGATED BURIAL RECORDS, INTERVIEWED LOCAL OFFICIALS, AND ULTIMOTELY REQUESTED THE EXHUMATION OF A BODY. THE EXHUMATION TOOK PLACE ON JULY 9, 1982. THE EMBASSY ARRANGED FOR A FORENSIC SPECIALIST TO EXAMINE THE REMAINS IN EL SALVADOR. HIS FINDINGS WERE FORWARDED TO THE U.S. AND REVIEWED BY A SPECIALIST WHO INDICATED THAT FURTHER REVIEW WAS NECESSARY BECAUSE THE SALVADORAN RESULTS WERE INCONCLUSIVE.
- Q: WHY DID IT TAKE SO LONG TO GET THE REMAINS SHIPPED TO THE U S $^{\circ}$
- A: AFTER THE REMAINS WERE EXHUMED LAST JULY, THEY WERE REBURIED BECAUSE SALVADORAN MEDICAL OFFICIALS CONCLUDED ON THE BASIS OF THEIR EXAMINATION, THAT THESE WERE NOT THE REMAINS OF JOHN SULLIVAN. HOWEVER, THE DEPARTMENT AND THE FAMILY ARRANGED FOR SPECIALISTS IN HE UNITED STATES TO EXAMINE THE X-RAYS TO RULE OUT ANY POSSIBILITY THAT THESE WERE THE REMAINS OF JOHN SULLIVAN. X-RAYS OF THE REMAINS WERE FORWARDED TO THE SULLIVAN FAMILY IN THE SUMMER AND IT WAS NOT UNTIL DECEMBER 1982 THAT THE DEPARTMENT WAS ADVISED THAT THERE WAS A HIGH PROBABILITY THAT THE REMAINS WERE THOSE OF SULLIVAN.
- Q: WHAT IS THE DEPARTMENT DOING TO SOLVE THE CASE OF JOHN SULLIVAN'S DEATH?
- A: THE EMBASSY HAS ACTIVELY PURSUED THIS CASE SINCE MR. SULLIVAN'S DISAPPEARANCE IN DECEMBER 1980. NOW THAT IT HAS BEEN ESTABLISHED THAT MR. SULLIVAN IS DEAD, WE WILL ASK THE GOVERNMENT OF EL SALVADOR TO REDOUBLE ITS EFFORTS TO FULLY INVESTIGATE THE TRAGIC CIRCUMSTANCES OF HIS DISAPPEARANCE AND DEATH.

- Q: DO YOU HAVE ANY COMMENT ON ALLEGATIONS BY THE

SULLIVAN FAMILY THAT THE DEPARTMENT DID NOT DO EVERYTHING POSSIBLE TO LOCATE THEIR SON? A: WE HAVE THROUGHOUT THE MORE THAN TWO YEARS SINCE JOHN SULLIVAN DISAPPEARED, ATTEMPTED TO FOLLOW UP ON ALL LEADS TO RESOLVE THIS CASE. A DEPARTMENT OFFICER HAS BEEN IN CLOSE AND FREQUENT CONTACT WITH MEMBERS OF THE SULLIVAN FAMILY. WE HAVE KEPT THE FAMILY, AS WELL AS THEIR CONGRESSIONAL REPRESENTATIVES, FULLY INFORMED OF DETAILS OF THE EFFORTS TO LOCATE MR. SULLIVAN. Q: WHAT CAN YOU TELL US ABOUT THE ANONYMOUS LETTERS RELATED TO THE SULLIVAN CASE RECEIVED BY THE EMBASSY DURING THE COURSE OF THE PAST TWO YEARS? A: THE U.S. EMBASSY IN SAN SALVADOR ATTEMPTED IN ALL INSTANCES TO ESTABLISH CONTACT WITH THE WRITERS OF THE ANONYMOUS LETTERS AND EFFORTS WERE MADE TO CROSS-CHECK THE INFORMATION PROVIDED IN THESE LETTERS. IN FACT, IT WAS AN ANONYMOUS LETTER WHICH DIRECTED THE ATTENTION OF THE EMBASSY TO THE SITE OF MR. SULLIVAN'S REMAINS. 4. SUMMARY OF NOON BRIEFING FEBRUARY 25 (ROMBERG): SPOKESMAN MADE THE ANNOUNCEMENT ABOUT THE RE-INTRODUCTION OF THE RADIO MARTI LEGISLATION, AND NOTED THAT A LONGER STATEMENT WOULD BE AVAILABLE IN THE PRESS OFFICE LATER IN THE AFTERNOON. THERE WERE NO FOLLOW-UP QUESTIONS. CHARDY OF THE MIAMI HERALD NOTED THAT REP. SOLARZ HAD SAID DURING SECY.
