ACTION MEDUINED: Pertinent Comments

- 1. After more than a year of procreatination and periodic, futile conversations between various UPDNING staffers, this entire case was alast laid into the capable hands of FRIEND, whose competence has been generally accepted by his wanner of handling UJ-UNGLINY # 1500 and # 1502. These conversations took place between UTILITY, @ Br. KLAUSHER (UPDNING CE chief), @ KURZ (UPDNING'S agent control officer who had been assigned a techs case officer role in this operation), @ Br. OFFO (special security advicer to UTILITY), and C. O (who actually "handled" the agent, V-70, @ KHLIM). Since at none or the meetings all of these officers were present, each one of them usually ended with one member referring another to either UTILITY or or both.

6. Regarding UJ-DOMB himself, @ FRIEGHS has so far reported little that is mer. 
