Request for Approval of Operational Expenditure to

Br. Ivan DOCHEY

- l. The objective of subject project is, in part, "to previde for those developmental activities that have not reached an operational degree sufficient to assume individual project status." Expenditure of FP operational funds for the above purpose in the amount of \_\_\_\_\_\_\_\_ has been authorised subject to availability of funds.
- 2. One of the sub-proposals of BGGGNVOX is "the FP development and exploitation of an emigre leader and/or his followers and such facilities as the newspaper published by the group."
- 3. On 15 July 1954 (as authorised by STG, British Liaison, etc.) contact was made with Br. Ivan BOCHEV, leader of the Bulgarian Mational Front, now resident in Ganada. In general, the meeting indicated that Br. BOCHEV may have operational assets for eventual training and use in infiltration operations into Bulgaria. By letter of 31 July 1954 (translation attached) Br. BOCHEV indicates that he has new furnished concrete plans for use operationally of a selected few of his followers in claudestine penetration operations.
- 4. As stated in enclosure in which we concur it is vital that the newspaper of the Bulgarian Mational Front continue to be published during the critical period while he is attempting to marshall his assets. Since BOCHEV claims that he receives no outside assistance, other than contributions from his followers, in financing this publication, he requests that we give financial assistance to ensure that an issue appear for 9 September 1954, the 10th anniversary of the Gemmenist seisure of Bulgaria.
- 5. We therefore request your approval that a maximum of \$500 be paid to Dr. BOCKEV, on his personal receipt, to assist in paying the
