1. REQUEST ARRANGE PROVISION TWO LETTER DROPS VICINITY FRANKFURT FOR BRIEFINGS NO LATER THAN 10 JUNE. DROPS SHOULD NOT BE POST OFFICE BOXES AND DO NOT NEED BE ACTUAL PERSONS BUT SHOULD BE NAME AND ADDRESS WHICH ASSURE OUR RECEIPT MAIL. DROPS WILL BE ACTIVE BETWEEN SEP 57 AND JUNE 58 WITH LETTER APPROX EVERY 60 DAYS FROM USSR CONTAINING S/W AND INNOCUOUS GERMAN COVER TEXT ON STUDENT LIFE, ETC. LETTERS RCVD SHOULD BE FORWARDED BOB.

2. IF DESIRED BOB CAN SUPPLY TEST LETTERS FROM BRLN AND FEDREP PRIOR ACTUAL RECEIPT OPERATIONAL MAIL IN ORDER ESTABLISH PATTERN FOR RECEIPT MAIL.

3. HAGU: WILL ALSO REQUIRE TWO LIVE DROPS HAGU OR AMSTERDAM AREA FOR SAME SITUATION PARA 1, BUT FOR DIFFERENT OPS.

4. DIR: ABOVE DROPS REQUIRED FOR AECANDY 1, AADJOIN AND AEPETRO OPS.

5. HAGU AND FROB PLS ADVISE CAPABILITY PROVISION THIS SUPPORT.
