2. WOULD LIKE YOUR REACTION FOLLOWING RESIGNED GET BOB LLDS FORTHWITH: UPON RECEIPT TRACES AND POA, WE RECRUIT, GIVE YOU OK SEND THRU TEST LETTERS. YOU PREPARE THESE, WE RETURN THEM BOB FOR CHECKING. ALSO, YOU ASSIGN EACH LLD AS YOU WISH, PASSING US NAMES, INDICATORS ETC. WE ALSO RETURN OPS LETTERS BOB. FROM FOB VIEWPOINT, OUR TASK LIMITED BRIEFING YOU ON RESTRICTIONS AND LIMITS EACH LLD AND SERVICING.
